## STATEMENT OF PURPOSE OF AMENDMENT:

The amendment reduces the transportation mileage payment for large buses from 68 cents to 67 cents. The Senate Education Committee had increased the large bus payments from 65 cents to 68 cents per mile. The following is a comparison of the total amount needed for transportation payments (included in Senate Bill No 2003) in the executive budget, Senate Education, and Senate Appropriation versions.

3. In determining the amount of payment due school districts for per-pupil aid under this section, the following amounts must be subtracted from the amount of such aid:

  - b. The amount that the unobligated balance of a school district's interim fund on the preceding June thirtieth is in excess of the amount authorized by section 57-15-27."
