REMARKS OF SENATOR SATROM

Mr. President and members of the Senate, I rise on a point of personal privilege. Mr. President and members of the Senate, it is our pleasure today to have a special nationally prominent guest with us, Mr. P. James Roosevelt, cousin of the former late President of the United States. I would like to offer a few remarks concerning the Roosevelt family and specifically, the twenty-sixth president.

Theodore Roosevelt said "It is not the critic who counts; not the man who points out how the strong man stumbles, or where the doer of deeds could have done better. The credit belongs to the man who is actually in the arena; whose face is marred by dust and sweat and blood; who strives valiantly; who errs and comes short again and again, because there is no effort without erring or shortcomings, but who does actually strive to do the deeds; who does the great enthusiasms, the great devotions; who spends himself in a worthy cause when the best knows in the end the triumph of high achievement; and who at the worst, if he fails, at least fails while daring greatly, so that his place shall never be with those cold and timid souls who know neither victory nor defeat." It always seemed to me that Theodore Roosevelt understood politics and probably the legislative process pretty well after those remarks of his.

Jim Roosevelt is a board member of the Theodore Roosevelt Medora Foundation. Over the period of recent years, he has been coming to those meetings regularly and with great devotion. He is a past president of the Theodore Roosevelt Association, a nationally chartered association to commemorate and preserve the history of the twenty-sixth president. I am proud to introduce Jim to the Senate today as a very loyal North Dakotan in the tradition of his cousin Theodore Roosevelt.

REMARKS OF P. JAMES ROOSEVELT

Obviously, I am honored more than I have been probably at any time in my life. But as Joe pointed out, let's not kid ourselves. The reasons you stood up and clapped, and the reason I am here is on account of one man, Theodore Roosevelt, and maybe even more importantly, because of one thing he said, which was, "If it had not been for my years in North Dakota, I would never have been President of the United States." Just think of that. What a connection, because for sure he is one of the ten most important people of the twentieth century, and if it had not been for North Dakota, that would not have been so. That is something you guys should be proud of, and ladies.

I do not want to take up your time. I know, as I say, you have given me more than you should, but I do want to say one thing that I am absolutely certain of: that if Theodore Roosevelt was here today and saw you ladies and gentlemen in action, he would have one word for it, and that one word would be "Bully"!
