- 3. This section does not require payment:
  - a. For services that would not be covered for any other licensed health care service provider under the contract, certificate, or policy of insurance or plan or agreement for health care services; or
  - b. For services where a doctor of chiropractic is already providing services under evidences of coverage or plans issued pursuant to chapter 26.1-18 or 26.1-47; or

- c. At higher than usual and customary amounts.
