- -- Provides \$3,000 from the general fund for the purchase of a computer and printer.
- -- The total change to the State Treasurer's office is a reduction of

one FTE position, from nine FTE to eight FTE; a general fund increase of \$58,303, from \$2,254,363 to \$2,312,666; and a reduction of special funds of \$121,248, from \$126,248 to \$5,000.

DEPARTMENT 125 - ATTORNEY GENERAL

This amendment makes the following changes to the Attorney General's office executive budget recommendation:

DEPARTMENT 127 - TAX COMMISSIONER

This amendment increases the operating expenses line item by \$48,000 from the general fund for employee training.

DEPARTMENT 401 - INSURANCE COMMISSIONER

This amendment increases the salaries and wages line item by \$77,194 and decreases operating expenses by the same amount. The \$77,194 was moved from operating expenses to salaries to provide funding for one FTE financial analyst position. Also, the \$22,806 remaining in operating expenses is for dues and professional fees and other reimbursements to fund legislative participation in the National Conference of Insurance Legislators. The amount of \$100,000 was originally provided in the bill for legal fees charged by the Attorney General for defense in a lawsuit and this funding is no longer considered necessary.

This amendment, in total, increases funding from the general fund by \$112,485, from \$39,230,713 to \$39,343,198 and decreases funding from special funds by \$24,780, from \$22,791,795 to \$22,767,015.
