- SECTION 1. AMENDMENT. Section 57-39.2-26.1 of the 1991 Supplement to the North Dakota Century Code is amended and reenacted as follows:
- 57-39.2-26.1. Allocation Determination of a portion of sales, use, and motor vehicle excise tax revenues to revenue sharing and personal property tax replacement. Notwithstanding any other provision of law, a  $\underline{A}$  portion of sales, use, and motor vehicle excise tax collections equal to sixty percent of an amount determined by

multiplying the quotient of one percent divided by the general sales tax rate, that was in effect when the taxes were collected, times the net sales, use, and motor vehicle excise tax collections under chapters 57-39.2, 57-40.2, and 57-40.3 must be deposited by the state treasurer in the state aid distribution fund. The determined by the state tax commissioner for each calendar year. The state tax commissioner shall certify to the state treasurer director of the office of management and budget the portion of sales, use, and motor vehicle excise tax net revenues that must be deposited in the state aid distribution fund as determined under this section. The state aid distribution fund must be allocated, subject to legislative appropriation, as follows:

- 1. Fifty percent of the revenues must be allocated in the first month subsequent to each quarterly period for state revenue sharing as provided in sections 54 27-20.2 and 54 27-20.3.
- 2. Fifty percent of the revenues must be allocated for personal property tax replacement as provided in section 57-58-01.

SECTION 2. APPROPRIATION. There is hereby appropriated out of any moneys in the general fund in the state treasury the sum of \$51,697,983, or so much of the sum as may be necessary, to the state treasurer for the biennium beginning July 1, 1993, and ending June 30, 1995, for the following purposes:

The state treasurer shall allocate fifty percent of the amount appropriated in this section for personal property tax replacement as provided in section 57-58-01 and fifty percent of the amount appropriated in this section for state revenue sharing as provided in sections 54-27-20.2 and 54-27-20.3. The state treasurer shall allocate personal property tax replacement revenues in two equal annual installments as provided in section 57-58-01 and shall allocate the revenues available for state revenue sharing in eight equal installments, within the first month subsequent to each quarterly period beginning with the quarterly period ending June 30, 1993.

SECTION 3. TRANSFER. On July 1, 1993, the state treasurer shall transfer the unobligated balance in the state aid distribution fund to the state general fund. Upon payment of all obligations, the state treasurer shall transfer any balance to the general fund in the state treasury. After June 30, 1993, the state treasurer shall deposit any moneys that would otherwise be deposited in the state aid distribution fund in the state general fund.

SECTION 4. EFFECTIVE DATE. Section 1 of this Act is effective for all sales tax revenues received after June 30, 1993."

# STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 085 - PAYMENTS TO POLITICAL SUBDIVISIONS

HOUSE - This amendment eliminates the state aid distribution fund and provides for all sales, use, and motor vehicle excise tax collections to be deposited into the general fund. The amendment requires the tax commissioner

to certify to the director of the Office of Management and Budget the portion of the sales, use, and motor vehicle excise tax collections that would have been deposited in the state aid distribution fund had the fund remained.

This amendment changes the funding source for payments to political subdivisions from the state aid distribution fund to the general fund and increases the appropriation by \$197,983, a portion of the balance in the state aid distribution fund as of June 30, 1991.

#### STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 701 - HISTORICAL SOCIETY

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The salaries and wages line item is decreased by \$93,928 from the general fund, of which \$19,584 is for reduced employee health insurance costs and \$74,344 is to reflect Governor Schafer's salary increase recommendation.

- To pay valid claims against cash deposit bonds posted by transient merchant licensees;
- To refund, upon expiration of the two-year period after the expiration of the transient merchant's license, the balance of any cash deposit bond remaining after the payment of valid claims:
- To pay costs, expenses, and attorney's fees and salaries incurred in the operation of the consumer fraud division; and
- To pay the actual costs of a background investigation of applicants for a gaming employee work permit investigations. licensing, and enforcement of gaming in the state or pursuant to Indian gaming compacts.

At the end of each fiscal year any moneys in the fund in excess of the amounts required for subsections 1, 2, 3, and 5 must be deposited in the general fund. The attorney general, with the concurrence of the director of the office of management and budget, shall establish the necessary accounting procedures for use of the attorney general refund fund, particularly with respect to expenditures under subsection 4."

- -- The information services line item is decreased by \$4,250 from the general fund to reflect a 10 percent decrease.
- The North Dakota-Saskatchewan-Manitoba Commission line item is reduced by \$2,000 from the general fund and the Yellow-Missouri-Fort Union Commission line item is reduced by \$2,000 from the general fund to reflect more accurately the anticipated expenditures for the two commissions for the 1993-95 biennium.

In total, this amendment reduces the appropriation to the Governor's office by \$420,208, of which \$166,576 is from the general fund and \$253,632 is from other funds.

#### DEPARTMENT 106 - LIEUTENANT GOVERNOR

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

-- The salaries and wages line item is decreased by \$9,754 from the general fund, of which \$1,152 is for reduced employee health insurance costs and \$8,602 is to reflect the Schafer salary increase recommendation. -- The interagency legal fees line item of \$2,962 is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.

Under the provisions of these amendments, the Lieutenant Governor's salary will remain at the current annual level of \$56,116.

In addition to the changes listed above, this amendment decreases the information services line item by \$87 from the general fund to reflect a 10 percent reduction.

In total, this amendment reduces the Lieutenant Governor's appropriation by \$12,803 from the general fund.

# DEPARTMENT 108 - SECRETARY OF STATE

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations for the Secretary of State:

- -- The salaries and wages line item is decreased by \$41,972 from the general fund, of which \$9,600 is for reduced employee health insurance costs and \$32,372 is to reflect Governor Schafer's salary increase recommendation.
- -- Under the provisions of this bill, the Secretary of State's salary remains at \$51,752 as under current law. The salaries and wages line is reduced by \$2,417 from the general fund to remove the two percent increase provided in Governor Schafer's budget.
- -- The interagency legal fees line item of \$39,389 is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.

The information services line item is decreased by \$125,428 (10 percent) from the general fund.

The general fund appropriation is increased by \$1,666,877, and estimated income is reduced by the same amount due to the Central Notice System being changed from other funds to the general fund. Section 17 is removed since it is no longer necessary. General fund revenue is also increased by \$1,666,877 relating to the change.

# DEPARTMENT 117 - STATE AUDITOR

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations for the State Auditor's office:

- -- The salaries and wages line item is decreased by \$125,966 of which \$81,877 is from the general fund and \$44,089 is from other funds. Of the \$125,966, \$21,888 is for reduced employee health insurance costs and \$104,078 is to reflect Governor Schafer's salary increase recommendation.
- -- Under the provisions of this bill, the State Auditor's salary will remain at \$51,752 as under current law. The salaries and wages line is reduced by \$2,417 from the general fund to remove the two percent increase provided in Governor Schafer's budget.
- -- The operating expenses line item is increased by \$1,290 and the interagency legal fees line item of \$12,825 is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General. The \$1,290 remains as the portion of legal fees

relating to other funds since the Attorney General will continue to charge special funded agencies for legal services.

This amendment does not reduce equipment by \$10,000 from the general fund as recommended in Governor Schafer's budget but maintains equipment funding as recommended in Governor Sinner's budget. The \$10,000 is for office furniture.

The information services line item is reduced by 10 percent of \$12,100. Of the \$12,100, \$10,165 is from the general fund and \$1,935 is from other funds.

Section 14 is changed to include the amended amount for the Political Subdivision Audit Division and appropriation language is removed to avoid duplicate appropriations.

# DEPARTMENT 120 - STATE TREASURER

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The salaries and wages line item is increased by \$53,958 from the general fund for one FTE liquor wholesale licensing previously recommended to be transferred to the Attorney General's office, decreased by \$2,688 from the general fund for reduced employee health insurance costs, and decreased by \$13,711 to reflect Governor Schafer's salary increase recommendation for a net general fund increase of \$37,559.
- -- The information services line item is increased by \$720 from the general fund for costs associated with the one FTE liquor wholesale licensing which was previously recommended to be transferred to the Attorney General's office.
- -- The operating expenses line item is increased by \$5,000 of other funds for liquor decals.
- -- The interagency legal fees line item of \$6,870 is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.
- -- Adds an estimated income line item of \$5,000, derived from the sale of liquor decals.

Under the provisions of this amendment, the State Treasurer's salary will remain at the current annual level of \$51,752.

In addition to the changes listed above, this amendment reduces the information services line item by \$2,709 from the general fund to reflect a 10 percent reduction.

In total, this amendment increases the State Treasurer's appropriation by \$33,700, of which \$28,700 is from the general fund and \$5,000 is other funds.

# DEPARTMENT 125 - ATTORNEY GENERAL'S OFFICE

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The information services line item is reduced by 10 percent, a reduction of \$26,384 from the general fund, and \$32,192 of other funds.
- -- The operating expenses line item is increased by a net amount of \$169,280 from the general fund consisting of a reduction of \$720 related to removal of the liquor tax licensing function and an increase of \$170,000 to remove the legal services contingency line item and transfer the funds to operating expenses.
- -- The interagency legal fees line item of \$47,572 from the general fund is removed.
- -- The legal services line item of \$170,000 from the general fund is eliminated and transferred to the operating expenses line item.
- -- The liquor decal revenue line of \$5,000 from other funds is eliminated.

The general fund appropriation is increased by a total of \$3,222,077, with a corresponding decrease to other funds to (1) reflect <u>not</u> billing general fund agencies for legal services of \$1,662,077 (This change consists of \$1,486,204 in the original recommendation and \$175,873 to reflect the change of the Insurance Commissioner, Banking and Financial Institutions, and the Industrial Commission (\$55,000) to general funding.) and (2) changing gaming enforcement funding to a general fund appropriation from gaming collections totaling \$1,560,000. A section is added providing that all gaming tax collections be deposited in the general fund.

A separate line item is added providing \$1,224,000 from the general fund for local gaming enforcement grants to cities and counties. A section is also added providing that the Attorney General distribute \$153,000 each quarter to the cities and counties based on the adjusted gross proceeds generated in each city or county.

A section is added expanding the use of funds in the Attorney General refund fund which the Attorney General may spend pursuant to a continuing appropriation, to include, in addition to investigations, licensing and gaming enforcement.

In addition, the amount to be spent from the fire and tornado fund is reduced by \$13,370 to reflect the revised salary and health insurance package.

In total, \$153,870 is added to the Attorney General's office appropriation including an increase of \$3,955,518 from the general fund, and a decrease of \$3,801,648 of other funds.

- The city sales tax income of \$400,000 is removed from other funds and replaced by a general fund appropriation. Income received related to the administrative fees will be deposited in the general fund. Section 4, which would have allowed the Tax Commissioner to retain the first \$400,000 of these collections in the department's operating fund, is removed.
- -- In total, \$584,712 is reduced from the Tax Commissioner's office appropriation including a decrease of \$184,712 from the general fund and a decrease of \$400,000 from other funds.

#### DEPARTMENT 401 - INSURANCE COMMISSIONER

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations for the Insurance Commissioner:

- -- The salaries and wages line item is decreased by \$104,455, of which \$69,176 is from the general fund and \$35,279 is from other funds. Of the \$104,455, \$16,898 is for reduced employee health insurance costs and \$87,557 is to reflect Governor Schafer's salary increase recommendation. The salaries and wages line is also decreased by \$3,883, of which \$3,106 is from the general fund, to correct an error in the bill as introduced.
- -- Under the provisions of this bill, the Insurance Commissioner's salary will remain at \$51,752, as under current law. The salaries and wages line is reduced by \$2,417 from the general fund to remove the two percent increase provided in Governor Schafer's budget.
- -- The interagency legal fees line item of \$17,000 is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.
- -- The boiler inspection line item is decreased by \$165 relating to the salary increase recommendation.
- -- The Securities Commission line item of \$696,882 is removed from the Insurance Commissioner's appropriation and included as a separate appropriation.

- -- The insurance tax to fire departments' appropriation of \$5,200,000 and the Insurance Commissioner's appropriation from the insurance regulatory trust fund of \$3,020,868 are changed from special funds to the general fund.
- -- Sections 7, 8, and 9 are changed to reflect the transfers necessary from the bonding, fire and tornado, and unsatisfied judgment funds after the amendments. A new section is added to reflect the amount of funding from the petroleum tank release fund. Section 18 is removed because it is not necessary since the insurance tax payments will be from the general fund.

In addition, salaries and wages are increased by \$110,755 from the general fund. The \$110,755 is to be used to retain employment of an actuary in order to remain accredited by the National Association of Insurance Commissioners. The remaining amount of the \$110,755 is to restore reductions made in the executive budgets. This increase is the same amount as the decreases to salaries and wages; therefore, the salaries and wages remain the same.

The information services line item is reduced by \$8,274 (10 percent) from the general fund.

#### DEPARTMENT 406 - LABOR COMMISSIONER

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The salaries and wages line item is decreased by \$18,642 from the general fund, of which \$3,072 is for reduced employee health insurance costs and \$15,570 is to reflect Governor Schafer's salary increase recommendation.
- -- The interagency legal fees line item of \$67,388 is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.

Under the provisions of this amendment, the Labor Commissioner's salary will remain at the current annual level of \$51,272.

In addition to the changes made to reflect Governor Schafer's recommended appropriation, this amendment makes the following changes:

- -- The salaries and wages line item is decreased by \$28,000 from the general fund for the elimination of one FTE, providing for total authorized FTE level of seven.
- -- The information services line item is decreased by \$2,500, of which \$2,167 is from the general fund and \$333 is from other funds to reflect a 10 percent reduction in Information Services Division.
- -- The operating expenses line item is increased by \$35,838, of which \$31,742 is from the general fund and \$4,096 is from other funds for indirect cost allocation payments to the general fund.

In total, this amendment reduces the Labor Commissioner's appropriation by \$80,692, of which \$84,455 is from the general fund and other funds are increased by \$3,763.

#### DEPARTMENT 408 - PUBLIC SERVICE COMMISSION

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The salaries and wages line item is decreased by \$219,394, of which \$158,323 is from the general fund. Of this reduction, \$19,201, \$9,600 of which is from the general fund, relates to reduced employee health insurance costs, \$110,193, \$58,723 of which is from the general fund, relates to Governor Schafer's salary increase recommendation for state employees, and \$90,000 from the general fund is to reflect additional funding available due to projected position vacancies during the 1993-95 biennium. Under provisions of these amendments, the salaries of the three Public Service Commissioners will remain at the current annual salary level of \$51,752 each.
- -- The operating expenses line item is increased by \$14,310 from special funds and the interagency legal fees line item of \$53,000, \$38,690 of which is from the general fund, is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.
- -- Funding for the Public Utility Division, proposed to be from special funds rather than the general fund, is returned to the general fund and the increased funding provided for the Public Utility Division, including one FTE position, is removed as follows:

- -- The information services line item is reduced by \$11,653, \$7,657 of which is from the general fund and \$3,996 of other funds to reflect a 10 percent decrease in information services.
- -- The operating expenses line item is increased by \$235,822, \$86,016 of which is from the general fund and \$149,806 of other funds for indirect cost allocation payments to the Office of Management and Budget.

In total, this amendment reduces funding for the Public Service Commission by \$212,576. General fund support for the Commission is increased by \$744,143 and funding from special funds is reduced by \$956,719. Authorized FTE positions are reduced by one FTE from 52 to 51 FTE positions.

#### DEPARTMENT 414 - SECURITIES COMMISSIONER

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

-- Governor Sinner's recommendation transferred the Securities Commissioner's budget in to the Insurance Commissioner's budget and Governor Schafer's recommendation leaves the Securities Commissioner as a separate budget.

- -- The salaries and wages line item includes \$518,638 from the general fund to provide funding for a total of seven FTEs.
- -- Includes \$18,246 from the general fund for information services, \$91,051 for operating expenses, and \$5,600 for equipment.

In addition to the changes listed above, this amendment also makes the following changes to Governor Schafer's recommended appropriations:

- -- The information services line item is decreased by \$1,825 from the general fund to reflect a 10 percent reduction.
- -- The operating expenses line item is decreased by \$29,000 from the general fund to eliminate \$3,000 included for payments to the State Auditor and \$26,000 for rent on the office space, neither of which is required because the agency is funded with general fund moneys.

In total, this amendment provides \$602,710 from the general fund, a decrease of \$94,172 from Governor Sinner's recommendation, for the Securities Commissioner.

DEPARTMENT 602 - AGRICULTURE COMMISSIONER

 $\mbox{HOUSE}$  - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The salaries and wages line item is decreased by \$86,234, of which \$69,471 is from the general fund. Of this reduction, \$15,362, \$12,290 of which is from the general fund, relates to reduced employee health insurance costs and \$70,872, \$57,181 of which is from the general fund, relates to Governor Schafer's salary increase recommendation for state employees. Under provisions of these amendments, the Agriculture Commissioner's salary will remain at the current annual level of \$51,752.
- The operating expenses line item is increased by \$14,875 from special funds and the interagency legal fees line item of \$119,493, \$104,618 of which is from the general fund, is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.
- Funding of \$115,000 from the general fund for rangeland grasshopper control is removed.
- Funding for the Agricultural Mediation Service is reduced by \$100,000 from the general fund, from \$600,000 to \$500,000, including two FTE positions. The department may continue to contract for additional mediators, if needed. Total funding provided for the Agricultural Mediation Service is \$1,792,037.
- -- Collections from Pride of Dakota and the Agricultural Mediation Service will be deposited in the general fund rather than the Agriculture Department's operating fund; therefore, \$45,000 for the Pride of Dakota program and \$100,000 for the agricultural mediation program are appropriated from the general fund rather than special funds.
- -- Funding for the brand registration program and livestock subprogram is eliminated, including 1.75 FTE positions. Duties of the livestock subprogram are to be conducted by other programs within the department. Reductions resulting from this change are:

This amendment also makes the following changes:

- -- The information services line item is reduced by \$8,775, \$7,972 of which is from the general fund and \$803 of other funds to reflect a 10 percent decrease in information services.
- -- The operating expenses line item is increased by \$213,034, \$116,168 of which is from the general fund and \$96,866 of other funds for indirect cost allocation payments to the general fund.
- -- The noxious weeds line item is increased by \$100,000. General fund support is reduced by \$100,000 and funding from the environment and rangeland protection fund is increased by \$200,000, reflecting the estimated amount appropriated from the fund for the 1991-93 biennium which will not be spent, and therefore available in the fund for the 1993-95 biennium.

In total, this amendment reduces funding for the Agriculture Department by \$240,182. General fund support is reduced by \$374,482 and funding from other funds is increased by \$134,300. Funding is provided for a total of 40.25 FTE positions, a reduction of 3.75 FTEs.

In total, funding provided in House Bill No. 1001 is reduced by 1.844,438. General fund support is increased by 14,080,588 and funding from other funds is reduced by 15,925,026.

The board shall meet at the call of the chairman, as is necessary to fulfill its duties under this chapter. The department commissioner of agriculture shall administer the agricultural mediation service. The commissioner of agriculture shall establish an agricultural mediation service to disseminate information to farmers concerning farm credit problems and to provide assistance to seek to resolve farm credit problems. The commissioner shall appoint an administrator of the agricultural mediation service. The commissioner shall hire staff, negotiators, and mediators who may mediate disputes involving farmers and others, either of whom may request assistance. The board may charge the farmer and others a reasonable fee for any assistance provided, such funds to be used to continue the service until June 30, 1993 deposited in the general fund in the state treasury. Fees charged to the farmer's creditors are limited to twenty-five dollars per hour, each, for the time spent in mediation sessions. The board shall adopt policies governing the negotiators, staff, and mediators hired under this section. Board members are entitled to receive sixty-five dollars for each day of official service, as directed by the board. The board members are entitled to expenses as provided in sections 44-08-04 and 54-06-09. The expenses provided under this section may be paid from any funds available in the home quarter purchase fund.
- SECTION 17. TRANSFER. On July 1, 1993, the state treasurer shall transfer the unobligated balance of the insurance regulatory trust fund and the insurance tax distribution fund to the general fund in the state treasury. After payment of all obligations of the insurance regulatory trust fund and the insurance tax distribution fund, the state treasurer shall transfer the balance to the general fund in the state treasury.
- SECTION 18. AMENDMENT. Section 26.1-01-07 of the 1991 Supplement to the North Dakota Century Code is amended and reenacted as follows:
- 26.1-01-07. Fees chargeable by commissioner. The commissioner shall charge and collect the following fees:
  - For filing articles of incorporation, or copies, or amendments thereof, twenty-five dollars.
  - For each original certificate of authority issued upon admittance, one hundred dollars and for renewal of certificate of authority, amendment to certificate of authority, or certified copy thereof, fifty dollars.
  - For issuing an annual reciprocal exchange license, the same fees as those applicable to the issuance of a certificate of authority in subsection 2.

- 4. For filing an annual report of a fraternal benefit society, and issuing a license or permit to the society, and for each renewal thereof, twenty-five dollars.
- 5. For filing bylaws or amendments thereof, ten dollars.
- For filing of articles of merger, or copies thereof, thirty dollars.
- For receiving the service of process as attorney, whether the commissioner is served with the process or admits service thereon, ten dollars.
- For filing of power of attorney by nonadmitted insurer for conduct of business in compliance with surplus lines laws of this state, ten dollars.
- 9. For filing an annual statement, twenty-five dollars.
- For each abstract of the annual statement of an insurance company for publication, ten dollars.
- 11. For an official examination, the expenses of the examination at the rate adopted by the department. The rates must be reasonably related to the direct and indirect costs of the examination, including but not limited to, actual travel expenses, including hotel and other living expenses, compensation of the examiner and other persons making the examination, and necessary attendant administrative costs of the department directly related to the examination and must be paid by the examined insurer together with compensation upon presentation by the department to the insurer of a detailed account of the charges and expenses after a detailed statement has been filed by the examiner and approved by the department.
- 12. For issuing a certificate to a domestic insurance company showing a compliance with the compulsory reserve provisions of this title and the maintenance of proper security deposits, and for any renewal of the certificate, ten dollars.
- 13. For a written licensee's examination administered by the office of the commissioner, with the examination not to exceed two lines of insurance at any one sitting, twenty dollars.
- 14. For a written licensee's examination not administered by the office of the commissioner under a contract with a testing service, the actual cost of the examination, subject to approval of the commissioner, which must be paid to the testing service.
- 15. For issuing and each annual renewal of a resident insurance broker's, surplus lines insurance broker's, insurance consultant's, health service corporation sales representative's, and prepaid legal services organization sales representative's license, or duplicate thereof, ten dollars.
- 16. For issuing and each annual renewal of a nonresident insurance broker's, health service corporation sales representative's, prepaid legal services organization sales representative's, and insurance consultant's license, or duplicate thereof, fifteen dollars.

- For issuing a license for a resident agent or limited insurance representative of a foreign insurance company, or duplicate, ten dollars.
- For issuing a nonresident insurance agent's or limited insurance representative's license, or duplicate, ten dollars.
- 19. For issuing a license for an agent or limited insurance representative of a domestic insurance company, county mutual insurance company, fraternal benefit society, or any other society, or duplicate, ten dollars.
- For issuing and each annual renewal of a license to a resident agent for the attorney for a reciprocal exchange, ten dollars.
- For filing of any miscellaneous documents or papers, including documents of admission and those filed annually upon license renewal, ten dollars each.
- For a copy of any paper filed in the commissioner's office, twenty cents per folio.
- For affixing the commissioner's official seal on a copy of any paper filed in the office and certifying the copy, ten dollars.
- For each insurance company appointment and renewal of an appointment of an insurance agent or limited insurance representative, ten dollars.
- 25. For each company application for admission, five hundred dollars, except applications for admission for county mutual, fraternal benefit, and surplus lines companies must be one hundred dollars.
- 26. For issuing a license and each annual renewal of a license to an insurance premium finance company, one hundred dollars.
- 27. For examining or investigating an insurance premium finance company, the actual expense and per diem incurred; but the per diem charge may not exceed fifty dollars.
- 28. For issuing and each annual renewal of a license to an advisory organization, or duplicate thereof, fifty dollars.

Nonprofit health service corporations and health maintenance organizations are subject to the same fees as any other insurance company. County mutual insurance companies and benevolent societies are liable only for the fees mentioned in subsections 2, 10, 11, 13, 19, 22, 23, and 24.

However, the commissioner may, after public notice and hearing, increase the fees authorized by this section for any year if it is determined necessary to generate the revenue appropriated by the legislative assembly from the insurance regulatory trust fund to fund budgeted operations for the insurance department. The insurance commissioner may not implement a fee increase pursuant to this section to enhance or in any manner add funds to the legislative appropriation for the insurance department.

SECTION 19. AMENDMENT. Subsection 1 of section 26.1-03-17 of the 1991 Supplement to the North Dakota Century Code is amended and reenacted as follows:

Before issuing the annual certificate required by law, the commissioner shall collect from every stock and mutual insurance company, nonprofit health service corporation, health maintenance organization, and prepaid legal service organization, except a fraternal benefit society, doing business in this state, a tax on the gross amount of premiums, assessments, membership fees, subscriber fees, policy fees, service fees collected by any third party administrator providing administrative services to a group that is self-insured for health care benefits, and finance and service charges received in this state during the preceding calendar year, at the rate of two percent with respect to life insurance, one and three-fourths percent with respect to accident and health insurance, and one and three-fourths percent with respect to all other lines of insurance. This tax does not apply to considerations for annuities. The total tax is payable on or before March first following the year for which the tax is assessable and must be deposited in the insurance tax distribution fund under section 18-04-04.1 but not in an amount exceeding two million six hundred thousand dollars in any fiscal year, and any amounts exceeding that amount must be deposited in the general fund in the state treasury. If the due date falls on a Saturday or legal holiday, the tax is payable on the next succeeding business day.

SECTION 20. AMENDMENT. Section 26.1-03-20 of the North Dakota Century Code is amended and reenacted as follows:

26.1-03-20. Examinations - By whom conducted - Compensation to be paid into insurance regulatory-trust fund. Qualified regular employees of the commissioner, or the commissioner's designated representatives acting as independent contract examiners under the direction of regular employees of the commissioner, shall conduct all examinations of an insurance company required or permitted by law to be conducted by the commissioner, whether or not the examinations are convention examinations called in accordance with rules promulgated by national association of insurance commissioners. compensation is to be paid out of the appropriation for the commissioner's office. Any sums paid to the employees or to the commissioner by the company examined, as an examination fee or otherwise, is state money, and forthwith must be paid into deposited in the insurance regulatory trust general fund in the state treasury. Any sums paid to the employee or the commissioner as expense money for the examiner may be paid directly to the employee, and no employee may charge or collect from the state any expenses incurred in connection with any examination for or during which expenses or any part thereof have been paid by any other person, firm, or corporation. However, independent contract examiners must be paid directly by the company examined after approval by the commissioner. The commissioner may contract for and procure the services of financial and market conduct examiners and other or additional specialized technical or professional assistants, as independent contractors. None of the persons providing those services or assistance on a contract or fee basis may be in the classified service of the state.

SECTION 21. TRANSFER. On July 1, 1993, the state treasurer shall transfer the unobligated balance of any moneys in the computerized Uniform Commercial Code central filing system fund to the general fund in the state treasury. Upon payment of all obligations,

the state treasurer shall transfer any balance to the general fund in the state treasury.

SECTION 22. AMENDMENT. Subsections 5, 9, and 10 of section 41-09-42 of the 1991 Supplement to the North Dakota Century Code are amended and reenacted as follows:

- 5. The fee for filing and indexing and for stamping a copy furnished by the secured party to show the date and place of filing for an original financing statement or for a continuation statement or to obtain information from the system is as follows:
  - a. For filing and indexing any statement under the Uniform Commercial Code, five dollars, and when a nonstandard statement is presented for filing, an additional fee of five dollars plus one dollar per page must be made. No additional fee may be charged if the form is filed also to gain protection under the central notice system.
  - For making certified copies of any recorded instrument, five seven dollars.
  - c. For completing a certificate requesting information, five seven dollars for the first five entries and one dollar two dollars for each additional five entries or fraction thereof.
  - d. For completing a certificate requesting copies, five seven dollars for the first three copies or fraction thereof, and one dollar two dollars for each additional copy.
  - e. For furnishing copies only of any filed instrument, one dollar.
- The fee for furnishing information on a verbal request pursuant to subsection 5 of section 41-09-46 is <u>five seven</u> dollars.
- The fee for furnishing a certificate pursuant to subsection 5 of section 41-09-46 is five seven dollars.

SECTION 23. AMENDMENT. Section 41-09-42.1 of the 1991 Supplement to the North Dakota Century Code is amended and reenacted as follows:

41-09-42.1. Creation of special fund— Fees collected by secretary of state. A special fund is hereby established in the state treasury to be known as the computerized Uniform Commercial Code central filing system fund. Any fees collected by the secretary of state pursuant to subsections 5, 8, 9, 10, and 11 of section 41-09-42 must be deposited in the computerized Uniform Commercial Code central filing system fund and may be spent within the limits of legislative appropriations for the purpose of implementing, maintaining, updating, and administering the computerized uniform Commercial Code central filing data base system, the computerized central notice system, and the computerized statutory lien data base system. This fund is not subject to section 54-44-1-11 general fund in the state treasury."

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

-- The salaries and wages line item was decreased by \$190,451 as follows:

- -- The interagency legal fees line item of \$124,000 from the general fund is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.
- -- The grant to the Consensus Council of \$50,000 from the general fund has been deleted.
- -- Changes the funding source for the capitol planning line item of \$200,000 from the capital construction fund to the Capitol building fund.

In addition to the changes made to reflect Governor Schafer's recommended appropriations this amendment makes the following changes:

- -- The information services line item was decreased by \$199,375, of which \$196,488 is from the general fund and \$2,887 is from other funds, to reflect a 10 percent reduction.
- -- The operating expenses line item was increased by \$44,614, of which \$43,346 is from other funds and \$1,268 is from the general fund for indirect cost allocation payments to the Office of Management and Budget.
- -- The operating expenses line item was increased by \$260 from the general fund for the purchasing division to make Merit System payments to the Central Personnel Division.
- -- A grants for homeless programs line item of \$40,000 from the general fund was established. A section of legislative intent was added stating that the \$40,000 is to be disbursed by the Office of Intergovernmental Assistance as grants and that none of the \$40,000 is to be used for administering the distribution of the grants.
- -- The state contingencies line item was increased by \$2,000,000 of other funds allowing the Emergency Commission to approve the acceptance and expenditure of special funds that may become available to state agencies between legislative sessions, pursuant to North Dakota Century Code Section 54-16-04.2.

-- The estimated income line item was increased by \$531,731 and the general fund appropriation was decreased by \$531,731 to reflect the funding source change for the Merit System within the Central Personnel Division of the Office of Management and Budget. It is intended that the Central Personnel Division will bill state agencies for the Merit System as has been done in the past. Amounts are being included in the agency budgets for the Merit System payments to the Central Personnel Division.

In total, this amendment increases the appropriation to the Office of Management and Budget central operations by \$1,521,048, of which \$1,031,419 is a general fund decrease and \$2,552,467 is an increase in other funds.

This amendment changes the state employee compensation adjustments guidelines to reflect Governor Schafer's recommendation for state employee salary increases.

This amendment adds a section of legislative intent regarding the billing of state agencies for indirect cost allocations.

This amendment changes the special fund transfers to be made during the 1993-95 biennium to reflect Governor Schafer's recommendation. The following schedule shows the change in special fund transfers:

-- The salaries and wages line item was decreased by \$81,149 from the general fund, of which \$22,248 is for reduced employee health insurance costs and \$58,901 is to reflect the Schafer salary increase recommendation.

- -- The building contingency line item of \$500,000 of general fund moneys is eliminated.
- -- Changes the funding source for the capital improvements line item to include \$300.000 from the Capitol building fund.

In addition to the changes made to reflect Governor Schafer's recommended appropriations, this amendment decreases the information services line item by \$3,200 from the general fund to reflect a 10 percent decrease.

In total, this amendment reduces the general fund appropriation to the Facility Management Division by \$884,349 and increases the other funds appropriation by \$300,000 for a net decrease of \$584,349.

# DEPARTMENT 112 - INFORMATION SERVICES DIVISION

HOUSE - This amendment makes the following change to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

-- The salaries and wages line item was decreased by \$280,368 of other funds, of which \$49,536 is for reduced employee health insurance costs and \$230,832 is to reflect the Schafer salary increase recommendation.

In addition to the changes made to reflect Governor Schafer's recommended appropriations, this amendment makes the following changes:

- -- Reduces the operating expenses line item by \$2,687,720 of other funds and the equipment line item by \$1,025,000 of other funds for a total reduction of \$3,712,720 of other funds to reflect a 10 percent reduction in the agency's appropriation. It is intended that the information services line item in each agency's budget is to be reduced by 10 percent, in conjunction with the 10 percent reduction in the Information Services Division appropriation.
- -- Increases the operating expenses line item by \$102,024 of other funds for indirect cost allocation payments to the Office of Management and Budget.

In total, this amendment reduces the appropriation to the Information Services Division by \$3,891,064 of other funds.

### DEPARTMENT 118 - CENTRAL DUPLICATING SERVICES

HOUSE - This amendment makes the following change to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

-- The salaries and wages line item was decreased by \$35,115 of other funds, of which \$8,832 is for reduced employee health insurance costs and \$26,283 is to reflect the Schafer salary increase recommendation.

In addition to the changes made to reflect Governor Schafer's recommended appropriations, this amendment makes the following changes:

- -- The information services line item was decreased by \$5,686 of other funds to reflect a 10 percent reduction.
- -- The operating expenses line item was increased by \$87,896 of other funds for indirect cost allocation payments to the Office of Management and Budget.

In total, this amendment increases the appropriation to Central Duplicating Services by \$47.095 of other funds.

DEPARTMENT 506 - STATE RADIO COMMUNICATIONS

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The salaries and wages line item was decreased by \$51,810 from the general fund, of which \$10,369 is for reduced employee health insurance costs and \$41,441 is to reflect the Schafer salary increase recommendation.
- -- The interagency legal fees line item of \$2,418 is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.

This amendment adds a section allowing State Radio Communications to carry over any unexpended amount from the 1991-93 biennium's equipment line item appropriation for the purchase of radio consoles which will not be purchased during the 1991-93 biennium due to lack of space.

In addition to the changes made to reflect Governor Schafer's recommended appropriations, this amendment makes the following changes:

- -- The information services line item was decreased by \$135,760 from the general fund to reflect a 10 percent reduction.
- -- The operating expenses line item was increased by \$23,194, of which \$21,188 is from the general fund and \$2,006 is from other funds for indirect cost allocation payments to the Office of Management and Budget.

In total, this amendment reduces the State Radio Communications general fund appropriation by \$168,800 and increases the other funds appropriation by \$2,006 for a net decrease of \$166,794.

In total, this amendment reduces the appropriations contained in this bill by \$3,074,064, of which \$2,084,568 is from the general fund and \$989,496 is from other funds.

It is the intent of the legislative assembly that the residential services currently provided at the school for the blind are to be discontinued by July 1, 1994, and that any cost savings from the elimination of residential services during the second year of the biennium beginning July 1, 1993, and ending June 30, 1995, are to be used to enhance the outreach services provided by the school."

This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations for the Department of Public Instruction:

- -- The salaries and wages line item is decreased by \$231,253, of which \$138,752 is from the general fund and \$92,501 is from other funds to reflect Governor Schafer's health insurance and salary increase recommendations. Of the \$231,253, \$46,080 is for reduced employee health insurance costs and \$185,173 is to reflect Governor Schafer's salary increase recommendation.
- -- Under the provisions of this bill, the Superintendent of Public Instruction's salary will remain at \$52,792 as under current law.
- -- The salaries and wages line item is further reduced by \$60,000 from the general fund and the operating expenses line item is reduced by \$40,000 from the general fund.
- -- The interagency legal fees line item of \$140,000 from the general fund is deleted to reflect Governor Schafer's recommendation regarding legal fees charged by the Attorney General.
- -- The School for the Blind line item of \$1,647,527 is removed and placed as a separate subdivision of the bill. Of the \$1,647,527, \$1,127,007 is from the general fund and \$520,520 is from other funds.

In addition, salaries and wages are reduced by \$305,000 from the general fund and operating expenses by \$25,000 from the general fund to delete four FTE positions. The department is to combine divisions in order to enhance administrative efficiency and therefore reduce the need for four FTEs which may include division directors. The deletion of the four FTE positions may occur over the course of the 1993-95 biennium.

The information services line item is reduced by \$70,241 or 10 percent. Of the \$70,241, \$41,386 is from the general fund and \$28,855 is from other funds.

The operating expenses line item is increased by \$588,498, of which \$428,118 is from the general fund and \$160,380 from other funds for indirect cost allocation payments to the Office of Management and Budget.

Special education grants are increased by \$535,624 from the general fund to increase state support for special education.

The special projects line item of \$7,000,000 is removed and separate line items are included amounting to \$6,250,000 as follows:

State film library - The salaries and wages line item is increased by \$166,030 from income of the State Film Library to fund up to four FTEs to continue operations of the film library. The executive budget had deleted funding for the program and related eight FTEs. In addition, a new section is added that appropriates, upon Emergency Commission approval, additional income received by the film library to fund additional FTE positions.

Foundation aid - The foundation aid line item of \$400,362,768 from the general fund is deleted. The amount to be provided for foundation aid will be appropriated in a different bill.

### DEPARTMENT 250 - STATE LIBRARY

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations for the State Library:

- The salaries and wages line item is decreased by \$45,051 from the general fund, of which \$10,752 is for reduced employee health insurance costs and \$34,299 is to reflect Governor Schafer's salary increase recommendation.
- -- Governor Sinner's budget recommendation that the State Library operate the talking book program for the visually impaired is deleted and additional funding to continue the library's contract with South Dakota is provided. Line item adjustments reflecting this change include:

-- Funding provided for a school library coordinator position and library development field services costs of \$30,621 from the general fund is charged to federal funds.

This amendment also reduces the grants to public libraries by \$50,000 from the general fund and adds \$50,000 from the general fund in a special line item to continue funding for the multitype library authority pilot project begun during the 1991-93 biennium to interface and integrate school, community, and public libraries in northwestern North Dakota.

The information services line item is reduced by \$8,011, \$6,911 of which is from the general fund to reflect a 10 percent decrease in information services.

The operating expenses line item is increased by \$151,408, \$105,836 of which is from the general fund for indirect cost allocation payments to the general fund.

In total, this amendment reduces funding for the State Library by \$34,302. General fund support is reduced by \$109,395 and other funds are increased by \$75,093. Authorized FTE positions are reduced by three FTEs, from 29.5 to 26.5.

# DEPARTMENT 252 - SCHOOL FOR THE DEAF

HOUSE - This amendment makes the following changes to Governor Sinner's executive budget recommendation to reflect Governor Schafer's recommended appropriations:

- -- The salaries and wages line item is decreased by \$92,467 from the general fund, of which \$18,432 is for reduced employee health insurance costs and \$74,035 is to reflect Governor Schafer's salary increase recommendation.
- -- The capital improvements line item is decreased by \$70,000 from the general fund. The remaining \$27,950 is for the following projects:

In addition to the changes listed above, this amendment makes the following changes:

- -- Provides authority for a .76 FTE librarian I for a total authorized FTE level of 50.73 but does not provide funding for the position.
- -- Reduces the information services line item by \$4,763, of which \$4,643 is from the general fund and \$120 is from other funds, to reflect a 10 percent decrease in information services.
- -- The operating expenses line item is decreased by \$50,000 from the general fund.
- -- The operating expenses line item is increased by \$39,062, of which \$28,120 is from the general fund and \$10,942 is from other funds for indirect cost allocation payments to the Office of Management and Budget.
- -- The equipment line item is decreased by \$5,000 from the general fund.

The estimated income line is decreased by \$734.151, corresponding increase in the general fund appropriation, for the following items previously contained in the estimated income line: Proceeds from sale of land \$ (16,000) designated for special purpose Title I library service (9,384)(federal funds) Billings to local (719,589)school districts Reduction in information (120)services line item Indirect cost allocation 10.942 payments

Total decrease \$(734,151)

In total, this amendment reduces the school's appropriation of other funds by \$734,151 and increases its general fund appropriation by \$550,983 for a net reduction of \$183.168.

DEPARTMENT 253 - NORTH DAKOTA SCHOOL FOR THE BLIND

HOUSE - This amendment eliminates the special line item of \$1,647,527, of which \$1,127,007 is from the general fund within the Department of Public Instruction subdivision and creates a separate subdivision with separate line items for the School for the Blind.

This amendment would provide for the following:

- -- Leave the school in Grand Forks.
- -- Provide funding for 34.95 FTEs.
- -- Eliminate the residential service component of the school effective July 1, 1994.
- -- Increase the estimated income line item by \$93,000 from all income sources, including rent on the dormitory building.
- -- Establish an information services line item of \$5,000 to be used by the school for connecting to the statewide accounting system, in the event the Department of Public Instruction discontinues providing the services to the school. If the Department of Public Instruction continues to provide the services, it is the intent that the school would get Emergency Commission approval to transfer the funds to operating expenses.
- -- Provides \$30,018 within the operating expenses line item, of which \$20,634 is from the general fund and \$9,384 is from other funds, for indirect cost allocation payments to the Office of Management and Budget.

This amendment also provides a section of legislative intent that any savings from the elimination of the residential services during the second year of the biennium is to be used to enhance the outreach services.

In total, this amendment increases the general fund appropriation to the school by \$1,192,687 in comparison to both Governor Sinner's and Governor Schafer's recommended general fund appropriations of \$1,127,007.
