There is hereby appropriated out of any moneys not otherwise appropriated, from special funds derived from federal funds, the sum of \$1,250,000, or so much of the sum as may be necessary, and out of any moneys in the general fund of the state treasury, not otherwise appropriated, the sum of \$1,250,000, or so much of the sum as may be necessary, to the department of human services for the purpose of carrying out its duties under section 21 of this Act for the biennium beginning July 1, 1993, and ending June 30, 1995."
