STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 720 - GAME AND FISH

SENATE - The salaries and wages line item is increased by \$204,653 to provide salary increases of three percent per year as recommended by Governor Sinner.

The information services line item is decreased by \$8,713 relating to information services rate reductions.

The operating expenses line item is increased by \$272,796 for indirect cost allocation payments to the Office of Management and Budget.

This amendment increases the maximum of the contingent appropriation by \$400,000, from \$600,000 to \$1,000,000. The amendments provide that the contingent appropriation is based on the amount the game and fish operating fund balance exceeds \$6 million on July 1, 1993, or \$5.5 million on July 1, 1994. The contingent appropriation, as provided by the House is also based on revenues exceeding estimates by \$150,000.

The amendment removes the provision that estimated revenues are to include revenue increases provided by the 1993 Legislative Assembly.

Also, the authority for the three FTEs deleted by the House is reinstated without funding. The three FTEs can be filled if additional funding becomes available.

A section is added that creates a new subsection to North Dakota Century Code Section 20.1-03-12 providing for an annual \$200 nonresident license to sell minnows or other live bait.

STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 750 - PARKS AND TOURISM DEPARTMENT

SENATE - This amendment makes the following changes:

- -- The salaries and wages line item is increased by \$71,882 from the general fund to reflect Governor Sinner's salary increase recommendation for state employees.
- -- The salaries and wages line item is also increased by \$70,000 from the general fund and the Williston and Bowman visitors' center line item of \$40,000 from the general fund is removed. The \$70,000 is provided for operating the Williston, Bowman, and Oriska visitor information centers during the 1993-95 biennium. A section is added providing that the department, after the 1994 tourism season, based on numbers of visitors and other factors, may close one of the visitor information centers.
- -- The information services line item is increased by \$9,155 from the general fund to restore a portion of the funding reduced by the House. The funding level provided reflects a reduction of \$1,045 from the executive recommendation relating to information services rate reductions.
- -- The operating expenses line item is reduced by \$89,672, \$61,924 of which is from the general fund, to remove funding for indirect cost allocation payments to the Office of Management and Budget.
- -- The parks and historic sites improvements line item of \$1,710,000, \$1,510,000 of which is from the general fund, is reduced by the items listed below which are transferred to other line items as follows:

The remaining \$1,159,450 in the parks and historic sites improvements line item is increased by \$334,732, \$234,732 of which is from the general fund and \$100,000 of federal funds. This line item total of \$1,494,182, \$1,194,182 of which is from the general fund, is provided for the following:

¹ It is the intent of the Legislative Assembly that projects consistent with completed historic sites, master plans at Fort Buford, Fort Totten, Pembina State Museum, the Chateau de Mores, and acquisition of the Boy Scout camp near Lake Metigoshe State Park be given high priority for expenditure of funds relating to this funding provided.

Rather than an interagency working group, a committee consisting of the Lieutenant Governor, one Senate Appropriations Committee member, one House Appropriations Committee member, the director of state parks, the director of state tourism, and a representative of the State Historical Board, is established to determine which parks and historic sites improvement projects the funds appropriated in the parks and historic sites improvements line item should be used for.

In total, this amendment increases funding for the Parks and Tourism Department by \$356,097, \$283,845 of which is from the general fund and \$72,252 of special funds.

STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 612 - AGRICULTURAL PRODUCTS UTILIZATION COMMISSION

SENATE - This amendment makes the following changes:

The salaries and wages line item is increased by \$12,220. General fund support is increased by \$46,551 and special funds are reduced by \$34,331. The increase is provided for:

The information services line item is increased by \$1,946 from the general fund. The funding level provided reflects a reduction of \$54 from the executive recommendation relating to information services rate reductions.

The operating expenses line item is increased by \$40,461. General fund support is increased by \$54,927 and special funds are reduced by \$14,466. The increase is to provide administrative costs relating to general fund grant programs.

The research, utilization, and marketing grants line item of \$1,691,395 of special funds is removed and funding for the following grant programs is added:

The section allowing funds appropriated for grants to be spent for both the 1993-95 and 1995-97 biennium is removed. It is the intent of the Legislative Assembly that the commission request appropriation authority from the 1995 Legislative Assembly for expenditures during the 1995-97 biennium relating to grants approved during the 1993-95 biennium.

The statutory changes relating to the agricultural fuel tax fund are removed which would have limited administrative costs of the commission and which would have removed the specific allocation of moneys in the fund for the various grant programs.

In total, this amendment increases funding for the Agricultural Products Utilization Commission by \$1,088,866. General fund support is increased by \$1,089,058 and special funds are reduced by \$192.

No person may engage in the practice of medicine, after the date set by the board for payment of the registration fee, without first paying the fee established under this section.
- On or before the tenth day of each month, the board shall pay into the general fund of the state treasury the total amount collected in the immediately preceding month pursuant to subsection 1.

SECTION 2. A new section to chapter 43-28 of the North Dakota Century Code is created and enacted as follows:

Annual fee - Paid to state treasurer.

- Each dentist, licensed and issued a certificate of registration under this chapter who practices dentistry in this state, shall pay an annual fee of three hundred dollars in addition to any fee otherwise charged under this chapter. The fee must be paid to the board before January first of each year. No person may engage in the practice of dentistry, after December 31, 1993, without first paying the fee established under this section.
- On or before the tenth day of each month, the board shall pay into the general fund of the state treasury the total amount collected in the immediately preceding month pursuant to subsection 1."

It is the intent of the legislative assembly that \$21,128,486 of the total funds appropriated to the department of human services, including the sum of \$5,592,115 derived from moneys in the general fund, be expended for the purpose of increasing the payments made to nursing facilities and intermediate care facilities for the mentally retarded in amounts sufficient to meet the rates set for services furnished in such facilities, for the purpose of providing an aggregate increase of five percent in the rates paid for physicians' services and dentists' services, and for the purpose of providing an aggregate increase of seven percent in the rates paid to hospitals, all with respect to services furnished to recipients of medical assistance benefits provided under chapter 50-24.1, for the biennium beginning July 1, 1993, and ending June 30, 1995. It is the intent of the legislative assembly that these increases not cause any payment amounts to exceed upper limits based on customary charges, as set forth in 42 CFR 447.271 or upper limits based upon reasonable estimations of what would have been paid for services under medicare payment principles, as set forth in 42 CFR 447.272. If there is any conflict between the intent that there be an increase of seven percent in the rates paid to hospitals and the intent that federal regulations governing upper limits be conformed to, the latter shall prevail.

SECTION 5. APPROPRIATION. There is hereby appropriated out of any moneys in the general fund of the state treasury, not otherwise appropriated, the sum of \$68,000, or so much of the sum as may be necessary, to the state tax commissioner for the purpose of administering the new chapter to title 57 created by this Act."
