Upon completion of the accreditation process, the institution shall submit evidence of accreditation, or a substantial good faith showing of progress toward such status. Only upon accreditation shall an institution become eligible for a regular authorization to operate. This section does not apply to institutions other than academic or professional postsecondary institutions that are domiciled in this state, and which enroll a limited number of students as determined by the board."
