STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 180 - SUPREME COURT

SENATE - This amendment reduces the salaries and wages line item by \$35,488 from the general fund, of which \$18,432 is for reduced employee health insurance costs and \$17,056 is to correct an error in the executive budget compensation plan.

This amendment increases the judges' retirement line item by \$17,056 from the general fund to correct an error in the executive budget compensation plan.

In total, this amendment decreases the appropriation to the Supreme Court by \$18,432 from the general fund.

DEPARTMENT 183 - JUDICIAL CONDUCT COMMISSION

SENATE - This amendment reduces the salaries and wages line item by \$29,040 from the general fund, of which \$1,536 is for reduced employee health insurance costs and \$27,504 is to correct an error in the executive budget compensation plan.

DEPARTMENT 185 - TRIAL COURTS

SENATE - This amendment reduces the salaries and wages line item by \$112,385 from the general fund, of which \$73,344 is for reduced employee health insurance costs and \$39,041 is to correct an error in the executive budget compensation plan.

This amendment increases the judges' retirement line item by \$39,041 from the general fund to correct an error in the executive budget compensation plan.

In total, this amendment decreases the appropriation to the trial courts by \$73,344 from the general fund.
