Let us pray. Gracious God, You have been the God of Abraham, Issac, and Jacob; of Washington and Adam and Lincoln, and we thank You that in our lifetime, through the voice of the people, You have called men and women to faithful service in the Legislature of this state. In this hour we remember, with respect and deep appreciation, those who have died since last this body met. Help each of us as citizens, as legislators, to be faithful to the opportunity and the responsibility they embraced in this Senate Chamber. The discipline of governing ourselves. Thank You that beyond the precious gift of memory, You have given us Hope. Hope that their labor will continue to bear good fruit and that in Your gift of Eternal Life, we will see them again. In Christ's Name we pray. Amen.

REMARKS BY PASTOR DEGROOT-NESDAHL

I would like to begin by sharing a reading from the Gospel of Matthew chapter 20, verses 25 through 28. These are the words of Jesus Christ: Jesus said to them "Whichever one of you would be first must be last. It will not be so among you. Whoever wishes to be great among you must be your servant. Whoever wishes to be first, must be your slave. Just as the Son of Man came not to be served, but to serve and to give His life a ransom for many." I bring you Grace and Peace from God our Father and from our Lord and Savior, Jesus the Christ.

Members of the Senate, honored guests, family members and special friends of those who are honored here today. It is certainly my privilege to be before you and to share some thoughts with you on this special occasion. To do that, I want to share with you a poem by a North Dakota poet. His name was James Foley and he wrote, many years ago now, a poem called "A Letter Home". It is one my Dad and I used to recite when I was growing up. He would take one verse, I would take the other; consequently, I only know half of the poem. But, I will not share it all, even the part that I know, with you this afternoon.

My Dad is being honored on the other side of the hall in a little while. He too served in this building in a special capacity as a Representative. It was two weeks ago today that we celebrated his funeral. I know that he loved North Dakota and that part of him will never die, and I know he loved this poem because he made sure that we learned it. So, I think he would enjoy that some of it was shared with you.

James Foley wrote home to his father on the east coast about what life on the prairie was like and how he would not be coming back to that east coast home where he had begun his life. He said words like these about North Dakota, about Dakota territory:

"There's a wholesomeness about it that I cannot quite explain; Once you breathe the air you love it and you long for it again. There's a tie you can't dissever in the splendor of the sky, It's just home to you forever and I just can't tell you why."

There is another verse that ends with these words: "And the mettle of it's people always ring so clear and true." I think it is those people whom we honor today. People who loved this prairie, and people who love those of us who live here. People who served us and cared deeply about the care of this land and of its people; and of its future. People who had a vision of life here that continued the vision that James Foley had many years before when he wrote about his idyllic experience. People who breathed this air and dared, who showed courage and commitment, who stood toe-to-toe with one another in forums like this one; but whose heart beat as one in service to those who sent them here.

These are really very ordinary North Dakota people that we honor here today. People of mettle; people who see the splendor of the sky; who felt the wholesomeness of this life and who protected and promoted it. These are ordinary people that we remember here today and their seats have been taken by more ordinary people like you. Their seats and their footsteps have been followed in by many of us and their memories are cherished by those who love them best. It is not their uniqueness that we honor, though some certainly distinguish themselves in these halls and across our state. It is not their ordinariness either that sets them apart today. We are "all" really ordinary. That is the wonder of living here. It is part of being North Dakotan. It is, however, their service that calls us together. Their lives of servanthood; to say it more Biblically.

Jesus himself describes that life in those Matthew verses I shared with you in these kinds of words: "Whoever wishes to be great among you must be your servant, and whoever wishes to be first among you must be your slave." Jesus is responding in those verses and in those prior. If you heard them read at your church this past Sunday, they were the appointed Gospel for the week in which He is responding to an inquiry about position. It comes from the mother of two of the diciples, James and John. The question seems to come from an understandable fear, a fear of a mother, a fear of a family member, a fear in fact probably of those diciples themselves. A fear of not receiving recognition for one's work. A modern translation in America today might rewrite this biblical verse to say: "Well, what's in it for me? What is all of this that I'm doing really worth in the end?" Surely people who are involved in public service like you are, and surely those of us who have been privileged to be related to public servants like we are, know the reality of questions like those in our heart of hearts and from time to time slipping off our tongues. We know where the question comes from. It comes from long hours of personal sacrifice and sometimes of attack. It comes from long hours over difficult decisions where no one really seems to come out as a winner in the end. It comes from tensions over loyalties and friendships and hours behind the wheel as you travel to and from that constituency who both loves you and tests you. Who challenges you and holds you up as a symbol of all they would have us be, both ordinary and great.

The list could go on. We don't always stay there in our thinking. We don't always even acknowledge that our thinking goes to those places, but Jesus certainly moves us back to the center of what service, public or personal, of any description really is about. Greatness is about servanthood. Being first comes from being lowly and Servanthood is about greatness. humble and serving others; in slaving oneself to a greater goal, to a higher vision, to a nobler cause than personal gratification, or often personal fullfillment. That is the mettle of our people that rings so clear and true in those who are honored here today; in those who surely follow after them. And it comes with these especially. It comes, that mettle, from their Christian faith. It is not really just a condition of living in North Dakota. It comes from a greater place. It comes from a relationship to the Great Suffering Servant for all of us. Jesus Christ.

I am very glad to be a part of this gathering today and that you have chosen to honor those who have served you so well in years past. But I am more than glad that their highest honor, these we named today; their true reward, their finest moment of satisfaction for a life well lived, can never be captured here. It can only be celebrated here. That is why what we do is so grand and appropriate. They have already claimed their seats at the side of the Savior and they have already heard Him say of them as He says of His children who come to Him: "Well done good and faithful servant. Whoever would be first among you, must be last. Whoever would be great in your midst, must be a servant."

In Jesus Name, help us be servants of Him. Amen.

SENATE - This amendment increases the salaries and wages line item by \$101,455, of which \$100,281 is from the general fund and \$1,174 is from other

funds. Of the total increase, \$60,531 from the general fund is for one FTE for the Veterans' Cemetery, \$40,924, of which \$39,750 is from the general fund and \$1,174 is from other funds, is to reflect Governor Sinner's salary increase recommendation for state employees.

This amendment increases the information services line item by \$1,788 from the general fund to restore a portion of the funding reduced by the House.

This amendment decreases the operating expenses line item by \$53,426, of which \$20,374 is from the general fund and \$33,052 is from other funds, to remove the indirect cost allocation payments to the Office of Management and Budget:

This amendment increases the Army Guard contract line item by \$56,381, of which \$3,615 is from the general fund and \$52,766 is from other funds, to reflect Governor Sinner's salary increase recommendation for state employees.

This amendment increases the Air Guard contract line item by 22,691, of which 5,324 is from the general fund and 17,367 is from other funds, to reflect Governor Sinner's salary increase recommendation for state employees.

In total, this amendment increases the appropriation to the Adjutant General by \$128.889, of which \$90.634 is from the general fund and \$38.255 is from other funds.
