COMMUNICATION FROM GOVERNOR EDWARD T. SCHAFER March 25, 1993

I am returning SB 2378 and hereby veto the same.

Community correction programs currently exist in Williston, Minot, Jamestown, and Richland County, and provide an excellent tool for local authorities as a sentencing option other than jail and also provide a method for repaying court costs, restitution, etc.

SB 2378, however, establishes regional boards, establishes a special fund up to \$508,000, and creates a cumbersome financing mechanism. A local surcharge is collected by misdemeanance at the local level, transferred to the state treasurer, and then returns 85% of the amounts collected to the regional boards and 15% to the Department of Corrections.

I believe that community correction programs are useful vehicles, but that SB 2378 creates an additional layer of government and is a cumbersome system for maintaining these programs at the local level.

I therefore am respectfully returning SB 2378, having vetoed the same.

- SECTION 2. A new section to chapter 43-28 of the North Dakota Century Code is created and enacted as follows:

Annual fee - Paid to state treasurer.

- Each dentist, licensed and issued a certificate of registration under this chapter who practices dentistry in this state, shall pay an annual fee of three hundred dollars in addition to any fee otherwise charged under this chapter. The fee must be paid to the board before January first of each year. No person may engage in the practice of dentistry, after December 31, 1993, without first paying the fee established under this section.
- On or before the tenth day of each month, the board shall pay into the general fund of the state treasury the total amount collected in the immediately preceding month pursuant to subsection 1."

"SECTION 4. LEGISLATIVE INTENT - IMPLEMENTATION EXPENDITURES. The appropriation for medical assistance in House Bill No. 1002 includes, in the estimated income line item, \$79,638,404 of special

funds derived from federal funds and other income, and \$27,451,668 in the total general fund appropriation line item derived from taxes and fees paid under this Act, for the purpose of defraying the expenses of the medical assistance program provided under chapter 50-24.1, for the biennium beginning July 1, 1993, and ending June 30, 1995.

It is the intent of the legislative assembly that \$17,869,581 of the total funds appropriated to the department of human services, including the sum of \$4,761,094 derived from moneys in the general fund, be expended for the purpose of increasing the payments made to nursing facilities and intermediate care facilities for the mentally retarded in amounts sufficient to meet the rates set for services furnished in such facilities, and for the purpose of providing an aggregate increase of five percent in the rates paid for physicians' services and dentists' services, all with respect to services furnished to recipients of medical assistance benefits provided under chapter 50-24.1, for the biennium beginning July 1, 1993, and ending June 30, 1995. It is the intent of the legislative assembly that these increases not cause any payment amounts to exceed upper limits based on customary charges, as set forth in 42 CFR 447.271 or upper limits based on reasonable estimations of what would have been paid for services under medicare payment principles, as set forth in 42 CFR 447.272.

SECTION 5. APPROPRIATION. There is hereby appropriated out of any moneys in the general fund of the state treasury, not otherwise appropriated, the sum of \$68,000, or so much of the sum as may be necessary, to the state tax commissioner for the purpose of administering the new chapter to title 57 created by this Act."

SECTION 3. STATE EMPLOYEE SALARY INCREASES - EFFECTIVE DATE. The amounts appropriated in section 2 of this Act are to be available to state agencies and institutions beginning on July 1, 1993, to be paid beginning on August 1, 1993, or later, to provide moneys in addition to amounts included in agency appropriations for employee compensation increases of seventy-five dollars per month. All state employees including temporary employees, not on a probation status are entitled to receive increases. Temporary and part-time employees must be provided a pro rata increase in accordance with the number of hours worked. Pay grade maximums may not be used to limit the amount of this increase.

SECTION 4. CONTINGENT APPROPRIATION. The sums hereinafter listed, or so much thereof as may be necessary, are hereby appropriated, subject to the availability of state general fund revenues as provided for in section 5 of this Act, out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income to the agencies and institutions of state government named for the purpose of providing additional compensation to employees for the various agencies and institutions for the period beginning August 1, 1994, and ending June 30, 1995:

SECTION 5. CONTINGENT APPROPRIATION. The amounts appropriated in section 4 of this Act are only to be available on August 1, 1994, after determination by the director of the office of management and budget that estimated general fund revenues for the fiscal year ended June 30, 1994, exceed the amount estimated at the close of the fifty-third legislative assembly by \$4,700,000. If general fund revenues exceed estimates, but are less than \$4,700,000 more than estimates, salary increases must be provided proportionately.

SECTION 6. STATE EMPLOYEE SALARY INCREASES - EFFECTIVE DATE. If the provisions of section 5 of this Act are met, the amounts appropriated in section 4 of this Act are to be available beginning on August 1, 1994, to be paid beginning on September 1, 1994, or later, for employee compensation increases of two percent. All state employees, including temporary employees, not on a probation status are entitled to receive increases. Temporary and part-time employees must be provided a pro rata increase in accordance with the number of hours worked. Pay grade maximums may not be used to limit the amount of this increase."

STATEMENT OF PURPOSE OF AMENDMENT:

DEPARTMENT 190 - RETIREMENT AND INVESTMENT OFFICE

SENATE - The information services line item is decreased by \$7,654 relating to information services rate reductions.

The operating expenses line item is increased by \$29,918 for indirect cost allocation payments to the Office of Management and Budget.

DEPARTMENT 192 - PUBLIC EMPLOYEES RETIREMENT SYSTEM

SENATE - The operating expenses line item is increased by \$43,706 for indirect cost allocation payments to the Office of Management and Budget.

The information services line item is decreased by \$11,144 relating to information services rate reductions.

This amendment adds a section appropriating the funding necessary in addition to the salary increase moneys contained in the various appropriations bills to provide state employees a \$75 per month salary increase in lieu of the proposed two percent increase contained in each bill.

This amendment also adds a section with a contingent appropriation to provide the funding necessary to provide state employees a two percent salary increase. The contingent appropriation requires general fund revenues as of June 30, 1994, to exceed the legislative forecast by an amount sufficient to pay for the general fund portion of the two percent salary increase.
