The balance in an account at a financial institution other than the Bank of North Dakota may not exceed the maximum amount of federal insurance coverage available unless the account is secured by another form of security or security deposit, and any check written on the account may be used only to transfer funds to the Bank of North Dakota or the state treasurer. A financial institution shall report to the state auditor in writing within thirty days after opening or closing an account for a state entity under this section. Subject to the approval of the state auditor, a state entity may maintain a cash balance reasonable for the conduct of business at the location of the entity.'
