 $\mbox{\bf REP. OBAN:} \mbox{ Mr. Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal, which request was granted.$

REMARKS OF REPRESENTATIVE OBAN

Mr. Speaker and members of the Assembly: This morning, the majority leader moved that HB 1258, which would give the governor veto power over actions of the Industrial Commission, be laid on the table. That means it will die without a vote when we adjourn sine die.

I was happy to see the committee's unanimous recommendation for a Do Not Pass. I believe it received that recommendation partly because the Governor withdrew his support. Despite the governor's position to the contrary, I believe HB 1258 represents bad public policy and is undemocratic. The poor timing of this bill is obvious to us all.

Mr. Speaker, I am saddened that the motion to lay HB 1258 on the table was offered. I recognize it is a nondebatable motion, but the huge Republican majority could have brought the bill to the floor and killed it - especially with a unanimous Do Not Pass committee recommendation.

As one legislator, I strongly disapprove of this rule. I believe it is clearly an attempt to avoid a difficult or controversial vote and debate - something the voters did not expect us to do when they voted for us last November.

I was hoping to use HB 1258 as one example of 16 bills introduced by the Governor or at his request that increase the powers of the Governor in a state that traditionally has resisted a strong Governor. All of us as members of the legislative branch need to be mindful of this power grab.

Many of the bills and resolutions remove power away from our constituents. This is also not what our constituents had in mind last November.
