POINT OF PERSONAL PRIVILEGE

REP. HOLM: Mr. Speaker: I rise on a point of personal privilege.

MOTION

REMARKS BY REPRESENTATIVE HOLM

Several weeks ago, when the House Education Committee presented House Bill No. 1041 to this Assembly, we assured each of you that there was not a fiscal note attached. The House Assembly members passed the bill 60 to 36. The House Education subcommittee spent many hours with Pat Laubach and the Legislative Council to write a bill to everyone's satisfaction. It was our desire to provide necessary services without imposing an additional fiscal note to the Department of Public Instruction (DPI). During our last meeting with the Legislative Council and Pat Laubach of the DPI, we were given assurances in answer to <u>direct</u> questions that this bill no longer contained a fiscal note. Our subcommittee and the House members acted on House Bill No. 1041 on the basis of the testimony we presented to you.

When Chairman Rydell assigned our subcommittee, she had it chaired by Representative Drovdal, who has many schools under a county superintendent. I was also appointed to the education subcommittee as a "fairness representative", because my county doesn't need the superintendent position. Representative Drovdal labored at every step to write a good piece of legislation for the schools in his district, while keeping the responsibility and control at the county and school district level. In his wisdom, he knew the time may come when this bill may receive a do-pass vote.

When this bill was presented to the Senate Education Committee by DPI on Tuesday morning, it came in with a fiscal note of \$225,000, along with pages of amendments and objections. The House Education subcommittee members worked with the DPI in good faith, and we were led to believe that we addressed every concern Pat Laubach had with the 62-page bill.

Now, I wish to respond to a remark made by a school principal and quoted in Wednesday's Bismarck Tribune. He said, "This bill was sold to the House committee under false pretenses". I have my testimony from our House hearing and I heard every comment on the bill. I stand by every word of our testimony. House Bill No. 1041 was thoroughly researched by Legislative Council's legal service, and Pat Laubach attended all our meetings, which I might add, were many hours. We thought the DPI was at least neutral on the bill, and they assured us there was no fiscal note.

Due to the actions of DPI on Tuesday, I want to go on record with several points I have listed below:

- The House Education Committee put in many good faith hours to write a good piece of legislation utilizing the assistance of Legislative Council and DPI. It is my belief that our committee did just that--we wrote, presented, and favorably voted a good educational bill.
- House Bill No. 1041 is our legislation, and it crossed over to the Senate without a \$225,000 fiscal note attached. I did not expect DPI to intercept it, or rewrite it. This is game playing and I

don't think it is appropriate, nor should it be their prerogative to alter our piece of legislation. Once this bill was passed, I believe that if DPI still had some problems with it, they should have exhibited common courtesy by contacting us to help resolve the issues. Instead, they waited until after it crossed over to the Senate, and then took it upon themselves to alter the bill to meet their satisfaction. Our entire subcommittee, along with the full committee, has been available at the Capitol every day to answer questions and resolve issues. In addition, many of us can be reached in the evenings as well. There simply isn't a justifiable reason for DPI to take things into their own hands by rewriting this bill and then presenting it to the Senate Education Committee with a fiscal note attached.

- 3. In answer to Ron Stastney's remark that counties cannot keep a superintendent, I would suggest that this is "permissive" legislation, and if a county wants to have ten superintendents, they can go ahead and have them.
- 4. If the DPI now feels their staff can't handle this statute without an additional \$225,000, I would suggest they replace some of their 132 employees with those who are competent enough to work within a reasonable budget.

When I came to Bismarck, I came to work for the people in my district--and all the people of North Dakota. I did not come here to waste endless hours playing games with an agency whose very reason for existence is to work for the people of this state. Many of my colleagues in the Legislature tell me that this happens all the time. I feel that members of this Legislative Assembly are working far too hard to put up with this kind of nonsense from an agency.

Finally, I want to say that I intentionally used names, but my intent is not to paint with a broad brush. There are people working in DPI whom I am deeply indebted to. Many have worked long endless hours to give us answers and support. The citizens of our state are fortunate to employ these people. They serve them well.
