The cost of constructing this plant is estimated to be \$245 million and that activity alone will involve 2,000-3,000 people over an eighteen-month period. When operational, the plant will annually process 25 million bushels of corn. Not only will the plant provide an economic boost to our corn farmers, it will also provide an economic benefit to southeastern North Dakota through the creation of 150 good-paying jobs.

Securing this plant would not have been possible without the tireless efforts of numerous people, including the Governor and the members of this Assembly.

When the Governor called us into special session in June 1994, there were skeptics among us. However, this Assembly's collective wisdom prevailed and we were able to amend our tax laws, thereby creating a favorable economic climate for ProGold.

I have no doubt that such legislative action played a major role in convincing ProGold that we in North Dakota are serious about economic development and that we are serious about creating an environment in which our children and grandchildren can grow and prosper.
