FIRST READING OF SENATE CONCURRENT RESOLUTION

Glassheim, Hagle, Mahoney, Rydell introduced: SCR 4019: A concurrent resolution for the amendment of sections 12 and 13 of article V, section 3 of article IX, and section 12 of article X of the Constitution of North Dakota, relating to the office of state treasurer and the department of labor; to repeal section 15 of article XII of the Constitution of North Dakota, relating to the duties of the state treasurer on issuance of legal tender by banks in the state; to provide for application; and to provide an effective date.
