SEN. YOCKIM: Mr. President Pro Tempore: This week North Dakota lost a fine public servant. Jim Haugen served in the North Dakota Legislature in the 1987 and 1989 sessions. He also had a distinguished record of service to the city of Williston from 1978 until 1986.

I was privileged to serve with Jim as a city commissioner and as a legislator. He quickly gained my respect and admiration as he struggled with the challenges of a city facing a boom/bust cycle. He conducted himself with grace, he fought for the things he believed in with vigor, and he looked upon his state with the eyes of a builder.

Jim's active public life often led many of us to overlook his private and personal struggles and achievements. It seemed that Jim would deal with personal or family issues and then the next day would start off on some new project to build his community.

Jim ran for and was elected mayor twice. Jim could have been reelected again and again, but he saw it was time to retire and he chose to do it.

Jim ran for and was elected to the state legislature two times. I have no doubt he would have been reelected again if he had chosen to run. He decided for his own reasons to retire.

None of us will fully know or understand what led to Jim's tragic death this week. But, as was his custom, he chose the time and place on his own terms.

I remember Jim as a hardworking, generous public servant, a mentor to me, and a builder of his community and state. I'll remember him as a colleague and a friend.

He was an avid card player who was fond of saying that one has to play the hand he is dealt. Jim did that and he did it well.

I hope that wherever Jim is at this point that he is in a card game and the great card dealer is dealing him a good hand.

Was read the first time and referred to the Natural Resources Committee.
