## REMARKS OF SENATOR MATHERN

Madam President: I served on the Interim Committee that addressed the issues of health care reform. This issue was brought to the Interim Committee by the last legislative assembly. We were to consider the PERS plan as one of the options to provide greater access for health insurance for our citizens.

There were five different options studied by the Interim Committee, the one before you was the one chosen by the Interim Committee to offer to this legislative assembly. This option was studied and a great deal of actuarial evidence was entered into the record. Each of the provisions of this bill provide clarification that implementation would not negatively affect the PERS plan. Once we addressed the actuarial issues I looked at this bill as one of fairness. Here we have a plan that is developed and paid for by the citizens of our state. The citizens provide me with this plan. This plan costs a family \$297 a month.

A NO vote is saying that these taxpayers that provide the plan for me cannot get the plan. To me it is like saying, when we had a problem with rust in the late fifties/early sixties and we developed Waldron, a rust resistant wheat, that even though this was a great wheat variety, we were only going to permit Waldron wheat to be used by legislators and state employees. Can you imagine the wrath of the citizens?

We have a program for giving people housing options through the North Dakota housing finance agency. We do some things to write down some interests and do some things to promote people to get housing and at the end of that we said, but the only people who can take advantage of this deal, even though the citizens paid for it, are legislators and state employees.

Voting NO on this bill is like saying we have a state university, we are proud of our state university, we have taken taxpayer money to build up that university, but we say only those people that are in the legislature or political subdivisions or state employees can take advantage of that university.

I think we have a plan here that is well-managed, it has a very strong orientation towards preventative care, it is a plan that is bid out to the private sector insurance companies. There are a lot of insurance companies who can bid for this product. The insurance company that gets the lowest bid offers the plan.

Let's proceed and give the citizens of our state the same opportunity to buy into this plan that we give ourselves. I encourage a YES vote on SB 2065.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 14-18-01 of the North Dakota Century Code is amended and reenacted as follows:

14-18-01. Definitions. As used in sections 14-18-01 through 14-18-07 this chapter:

- "Assisted conception" means a pregnancy resulting from insemination of an egg of a woman with sperm of a man by means other than sexual intercourse or by removal and implantation of an embryo after sexual intercourse, but does not include the <u>a</u> pregnancy of <u>a wife</u> resulting from the insemination of her <u>an</u> egg of <u>a wife</u> using her husband's sperm.
- "Donor" means an individual whose body produces sperm or egg used for the purpose of assisted conception, whether or not a

payment is made for the sperm or egg used, but does not include a woman who gives birth to a resulting child an individual whose body produces sperm or egg used for the purpose of conceiving a child for that individual.

- "Gestational carrier" means an adult woman who enters into an agreement to have an embryo implanted in her and bear the resulting child for intended parents, where the embryo is conceived by using the egg and sperm of the intended parents.
- 4. "Surrogate" means an adult woman who enters into an agreement to bear a child conceived through assisted conception for intended parents.

SECTION 2. A new section to chapter 14-18 of the North Dakota Century Code is created and enacted as follows:

<u>Paternity.</u> <u>Paternity of a child born to a gestational carrier is</u> <u>governed by chapter 14-17.</u>

SECTION 3. REPEAL. Section 14-18-02 of the North Dakota Century Code is repealed.

SECTION 4. EMERGENCY. This Act is declared to be an emergency measure."
