4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new section to chapter 49-05 of the North Dakota Century Code is created and enacted as follows:

Rate adjustment - Transmission facility costs.

- The commission may approve, reject, or modify a tariff filed under section 49-05-06 which provides for an automatic adjustment of rates to recover jurisdictional capital and operating costs incurred by a public utility for new or modified electric transmission facilities. For purposes of this section, an electric transmission facility includes an electric transmission line as defined in chapter 49-21.1 and other transmission line equipment, including substations, transformers, and other equipment constructed to improve the power delivery capability or reliability of the electric transmission system; and operating costs include federally regulated costs charged to or incurred by the public utility to increase regional transmission capacity or reliability. The tariff must:
 - a. Allow the public utility to recover on a timely basis its investment and
 associated costs for new or modified electric transmission facilities not
 reflected in the utility's general rate schedule;
 - <u>Allow a return on the public utility's investment made for new or modified</u>
 <u>electric transmission facilities at the level approved in the utility's most recent</u>
 general rate case;

1 Provide a current return on construction work in progress for new or modified C. 2 electric transmission facilities, provided the cost recovery from retail 3 customers of the allowance for funds used during construction is not sought 4 through any other means; and 5 Terminate cost recovery after the public utility's costs for new or modified d. 6 electric transmission facilities have been recovered fully or have been 7 reflected in the utility's general rate tariffs. 8 Rate adjustments filed under the tariff must be accompanied by: 2. 9 A description and quantification of the costs incurred by the public utility for a. 10 new or modified electric transmission facilities which are subject to recovery; 11 A schedule for implementation of the applicable transmission facility projects; <u>b.</u> 12 and 13 Calculations to establish that the rate adjustment is consistent with the terms C. 14 of the tariff. 15 <u>3.</u> Upon receipt of a rate adjustment filed under the tariff, the commission shall 16 approve the rate adjustment to become effective unless, after notice and 17 opportunity for hearing and comment, the commission determines the rate 18 adjustment does not comply with the tariff or the incurred costs for new or modified 19 electric transmission facilities are not reasonable and prudent. The commission 20 may order the public utility to pay the expenses of investigating rate adjustments 21 for recovery of transmission facility costs under this section in accordance with 22 section 49-02-02.
