CHAPTER 136.

PROHIBITING THE MANUFACTURE, USE AND SALE OF CERTAIN EXPLOSIVES.

AN ACT To Prohibit the Manufacture, Use and Sale of Blank Cartridges, Fire Arms, Certain Fire Crackers and Certain other Explosives.

Be It Enacted by the Legislative Assembly of the State of North Dakota:

§ 1. MISDEMEANOR TO MANUFACTURE OR SELL.] Every person who shall manufacture, use, sell or keep for sale within the state any blank cartridges, pistols, blank cartridge revolver, or other blank cartridge, fire arms, blank cartridge caps, containing dynamite, and fire crackers, exceeding three inches in length, and exceeding one-half of an inch in diameter shall be guilty of a misdemeanor.

§ 2. This act shall take effect and be in force from and after its passage and approval.

FOREIGN CORPORATIONS

CHAPTER 137.

REGARDING FOREIGN CORPORATIONS.

AN ACT To Amend Sections 4695 and 4698 of the Revised Codes of North Dakota for 1905, Relating to Foreign Corporations.

Be It Enacted by the Legislative Assembly of the State of North Dakota:

§ 1. That Section 4695 of the Revised Codes of North Dakota for 1905 be and the same is hereby amended to read as follows:

§ 4695. FOREIGN CORPORATIONS CAN DO BUSINESS IN THIS STATE WHEN.] No foreign corporation, association or joint stock company, except an insurance company shall sell or otherwise dispose of its capital stock or transact any business within this state, or acquire, hold or dispose of property real or personal within this state, until such corporation shall have filed in the office of the secretary of state a duly authenticated copy of its charter, articles of incorporation, and by laws, and shall have complied with the provisions of this chapter; provided that the provisions of this chapter shall not apply to corporations created for religious or charitable purposes solely nor to the holding and disposing of such real estate as may be acquired only by foreclosure or otherwise, in liquidation of mortgages or other securities by corporations which may not have complied with the provisions of this article.

§ 2. That Section 4698 of the Revised Codes of North Dakota for 1905 be and the same is hereby amended to read as follows:

§ 4698. LIABILITY OF OFFICERS, ETC. FOR FAILURE TO COMPLY.] Any failure to comply with the provisions of the last three sections and with section 3116 of this code shall render each and every officer, agent or stockholder of any corporation, association or joint stock company failing to comply therewith, jointly and severally liable on any and all contracts of such corporation, association or joint stock company made within this state during the time such corporation, association or joint stock company is so in default. Each and every officer and agent of such corporation, shall further be deemed guilty of a misdemeanor.

§ 3. REPEAL.] All acts or parts of acts in conflict with the provisions of this act are hereby repealed.

CHAPTER 138.

PROHIBITING OF FREE PASSES.

AN ACT To Prohibit the Granting to or Use by any Person of any Free Pass, Frank, or Special Privilege Withheld From Any Other Person, and Fixing the Penalty for the Violation Thereof, except as Provided Therein.

Be It Enacted by the Legislative Assembly of the State of North Dakota:

§ 1. FREE PASSES, FRANKS AND SPECIAL PRIVILEGES PROHIBITED. EXCEPTIONS.] No common carrier subject to the provisions of this act, shall, directly or indirectly, issue or give any free ticket, free pass or free transportation for passengers except to its employes and their families, its officers, bona fide agents, surgeons, physicians and attorneys at law on the pay roll of the common carrier; to ministers of religion, traveling secretaries of railroad, Young Men's Christian Association, inmates of hos-
