CHAPTER 370

HOUSE BILL NO. 1606
(L. Hanson, W. Williams)

COMPENSATION OF MUNICIPAL COURT WITNESSES

AN ACT to amend and reenact section 31-01-16.2 of the North Dakota Century Code, relating to compensation of municipal court witnesses.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE
STATE OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 31-01-16.2 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

31-01-16.2. Compensation of municipal court witnesses. A witness in the court of a municipal judge court shall be entitled to receive the amount of two five dollars and fifty cents for each hour necessarily spent in municipal court, and but in no instance shall compensation be more than five seven dollars and fifty cents for any such appearance.

CHAPTER 371

NONRESIDENT WITNESS MILEAGE AND FEES

AN ACT to amend and reenact section 31-03-29 of the North Dakota Century Code, relating to mileage and fees of witnesses from another state.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE
STATE OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 31-03-29 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

31-03-29. Mileage and fees of witness from another state - Length of time to remain in state. If the witness from another state is summoned to attend and testify in a criminal prosecution in this state, he shall be tendered the sum of ten cents a mile for each mile, by the ordinarily traveled route, to and from the court where the prosecution is pending, and five dollars for each day that he is required to travel and attend as a witness the witness is entitled to the fees and expenses provided to witnesses under section 31-01-16. A witness who has appeared in accordance with the provisions of the summons shall not be required to remain within this state for a longer period of time than the period mentioned in the certificate.

CHAPTER 372

TRANSCRIPT BY ELECTRONIC COURT REPORTING SYSTEM

AN ACT to amend and reenact section 31-09-03 of the North Dakota Century Code, relating to use of a transcript from an electronic court reporting system as evidence; and to declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE
STATE OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 31-09-03 of the North Dakota Century Code is hereby amended and reenacted to read as follows:

31-09-03. Stenographic report or transcript as evidence. Whenever the testimony of a witness at a trial or hearing which was reported stenographically or by an electronic court reporting system is admissible in evidence at a trial, it may be proved by the transcript thereof duly certified by the person who reported or transcribed the testimony.

SECTION 2. EMERGENCY. This Act is hereby declared to be an emergency measure and is in effect from and after its passage and approval.
