- 2 procedures; to create and enact two new sections to chapter 54-03 of the North Dakota Century
- 3 Code, relating to legislative redistricting and staggering of terms of members of the legislative
- 4 assembly; to repeal sections 54-03-01.12 and 54-03-01.13 of the North Dakota Century Code,
- 5 relating to legislative districts and staggering of terms of members of the legislative assembly; to
- 6 provide a statement of legislative intent; and to provide an effective date.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- **SECTION 1.** A new section to chapter 54-03 of the North Dakota Century Code is created and enacted as follows:

- Each legislative district is entitled to one senator and two representatives. The legislative districts of the state are formed as follows:
 - 1. District 1 consists of that part of the city of Williston and Stony Creek and Williston
 Townships in Williams County bound by a line commencing at the point where the
 centerline of thirty-second avenue intersects the centerline of twenty-sixth street, then
 east on twenty-sixth street until it becomes the southern property line of the sloulin
 field international airport, then east and north on the southern property line of the
 sloulin field international airport until its intersection with the centerline of United States
 highway 2, then south on United States highway 2 until its intersection with the
 centerline of twenty-sixth street, then east on twenty-sixth street until it curves north
 and turns into thirteenth avenue, then east on an extended straight line until its
 intersection with the western boundary of Stony Creek Township, then south and east
 on the west boundary of Stony Creek Township until its intersection with the west bank
 of the Little Muddy River, then south on the west bank of the Little Muddy River until its

- intersection with the shoreline of Lake Sakakawea, then south and west on the
 shoreline of Lake Sakakawea until its intersection with the centerline of one hundred
 thirty-eighth avenue, then north on one hundred thirty-eighth avenue until it becomes
 thirty-second avenue, then north on thirty-second avenue to the point of beginning.
 - District 2 consists of all of Divide County except Mentor, Coalfield, Upland, Border, Hayland, and Stoneview Townships; Bicker, Powers Lake, Powers, Lostwood, White Earth, Sorkness, Cottonwood, James Hill, Myrtle, Manitou, Ross, and Idaho Townships in Mountrail County; and all of Williams County except Marshall, Springbrook, Brooklyn, View, Farmvale, Dry Fork, Twelve Mile, Truax, Southeast Williams, Hardscrabble, Buford, Trenton, and Judson Townships, the portions of Williston and Stony Creek Townships contained in District 1, and the portions of Williston Township contained in District 23.
 - District 3 consists of Surrey, New Prairie, Sawyer, Brillian, and Greely Townships in 3. Ward County; that part of Newman and lota Flat Townships in Ward County bound by a line commencing at the point where the center line of fifty-fifth street intersects the north boundary of Newman Township, then east on the north boundary of Newman Township until its intersection with the east boundary of Newman Township, then south on the east boundary of Newman Township and continuing south on the east boundary of lota Flat Township until its intersection with the south boundary of lota Flat Township, then west on the south boundary of lota Flat Township until its intersection with the centerline of fifty-fifth street, then north on fifty-fifth street to the point of beginning; that part of Sundre Township in Ward County bound by a line commencing at the point where the west boundary of Sundre Township intersects the north boundary of Sundre Township, then east on the north boundary of Sundre Township until its intersection with the east boundary of Sundre Township, then south on the east boundary of Sundre Township until its intersection with the south boundary of Sundre Township, then west on the south boundary of Sundre Township with its intersection with the centerline of forty-second street, then north on forty-second street until its intersection with the north boundary of Sundre Township, then west on the north boundary of Sundre Township until its intersection with the centerline of twentyseventh street, then south on twenty-seventh street and continuing in a straight line

1 Staggering of terms of members of the legislative assembly.

- A senator and two representatives must be elected from each odd-numbered district in
 2022 for a term of four years.
- 4 2. A senator and two representatives must be elected from each even-numbered district
 5 in 2022 for a term of two years and in 2024 for a term of four years.
- SECTION 3. REPEAL. Sections 54-03-01.12 and 54-03-01.13 of the North Dakota Century
 Code are repealed.

SECTION 4. SECRETARY OF STATE TO MODIFY ELECTION DEADLINES AND

- **PROCEDURES.** If, as a result of a delay in implementation of this Act, it becomes necessary to modify election deadlines and procedures for the conduct of the 2022 primary election, the secretary of state, in consultation with city and county election officials, shall adopt modified election deadlines and procedures to allow the conduct of the 2022 primary election as scheduled. The modified deadlines and procedures may address filing and publishing deadlines and any other matters necessary to accommodate the conduct of the primary election.
- SECTION 5. LEGISLATIVE INTENT BOUNDARIES. It is the intent of the legislative assembly that, although this Act is effective on the day on which it is filed, the members of the legislative assembly elected under the redistricting plan in effect the day before this Act becomes effective shall continue to serve until implementation of this Act. Any reference in the legislative district descriptions to a city limit or a reservation boundary as a boundary line refers to the limit or boundary as it existed on January 1, 2020, as shown on the 2020 census maps. A legislative district boundary using a reservation boundary or city limit lines does not migrate as the reservation boundary or city limits migrate. For purposes of legislative district descriptions, unless cities are otherwise specifically named, townships encompass all the territory within their outer boundaries.
- **SECTION 6. EFFECTIVE DATE.** This Act becomes effective upon its filing with the secretary of state.
