NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota Board of Cosmetology will hold a public hearing to address proposed amendments to N.D. Admin. Code title 32 at 1:00 p.m. on September 15, 2016, at the Board's Office, 1102 S. Washington Street, Suite 200, Bismarck, N.D. The purpose of the proposed amendments is to clarify and update the laws regarding the practice of cosmetology, manicuring, and esthetics. The proposed amendments address licensing standards and cleaning and disinfecting. The proposed rulemaking implements bill number 2097, enacted during the most recent legislative session, concerning cosmetology, manicuring, and esthetics. The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000.

The proposed rules may be reviewed at the office of the North Dakota Board of Cosmetology, 1102 S. Washington Street, Suite 200, Bismarck, N.D., 58502. A copy of the proposed rules and/or a regulatory analysis may be requested by writing the above address, e-mailing info@ndcosmetology.com, or calling 701-224-9800. Written or oral comments on the proposed rules sent to the above address or telephone number and received by September 26, 2016 will be fully considered.
