Sections being amended include provisions for the regulation of anhydrous ammonia, sections being adopted include provisions for the regulation of emerald ash borer, commercial feed, and pet food and specialty pet food.

#### NOTICE OF INTENT TO ADOPT, AMEND, AND REPEAL ADMINISTRATIVE RULES PERTAINING TO PROGRAMS ADMINISTERED UNDER THE AUTHORITY OF THE NORTH DAKOTA DEPARTMENT OF AGRICULTURE

TAKE NOTICE that the North Dakota Department of Agriculture will hold a public hearing to address proposed amendments to and repeal of N.D. Admin. Code Article 7 at **9 a.m. on Monday, March 16, 2020, at the Fort Lincoln Room** at the State Capitol. The purpose of the proposed adoptions, amendments, and repeal is to update the Administrative Rules pertaining to programs administered under the authority of the North Dakota Department of Agriculture. The changes being made to each article and section listed are to reflect the current operations of the agency.

Specifically, NDDA is proposing the following adoptions and repeal to N.D. Admin. Code Chapter 7:

- 1. Adopt N.D. Admin Code § 7-04-04-04 to provide regulation regarding emerald ash borer, 9 a.m. 10 a.m.;
- 2. Repeal N.D. Admin Code § 7-06 regarding noxious weeds, 9 a.m. 10 a.m.;
- 3. Amend N.D. Admin Code § 7-09 regarding the Pride of Dakota program, 10 a.m. 11 a.m.;
- Amend N.D. Admin Code § 7-12-01 regarding anhydrous ammonia regulation in response to Senate Bill 2152, 11 a.m. – 12 p.m.;
- Adopt N.D. Admin Code § 7-16 regarding the regulation of commercial feed in response to House Bill 1134, 1 p.m. – 2 p.m.; and
- Adopt N.D. Admin Code § 7-17 regarding the regulation of pet food and specialty pet food in response to House Bill 1134, 1 p.m. – 2 p.m.
