## NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota Department of Commerce will hold a public hearing to address proposed amendments to the N.D. Admin. Code Third Party Inspections Program, Article 108-02, Chapter 108-02-01, and sections 108-02-01-01, 108-02-01-03, 108-02-01-07, 108-02-01-08,108-02-01-09, 108-02-01-10, 108-02-01-11, and 108-02-01-12 Manufactured Home Installation Program, Article 108-03. Chapter 108-03-01. and sections 108-03-01-03. 108-03-01-04. 108-03-01-06. 108-03-01-09, 108-03-01-10, 108-03-01-11, 108-03-01-12, 108-03-01-13, 108-03-01-14, 108-03-01-16, 108-03-01-17, and 108-03-01-19 at 9:00 AM on Friday, January 3rd, 2020, at 1600 East Century Ave. Suite 2, Bismarck, ND, 58503. The purpose of the proposed amendments to the Manufactured Home Installation Program is to adopt clarifying language required by the most recent audit of the program, insert a recommendation from the Manufactured Housing Association to remove the language that allows certified inspectors, changes the training schedule from every year to every three years, changes a section that is in conflict with federal law, and sets and updates the fee structure. The purpose of the proposed amendments to the Third Party Inspection Program are to adopt the most recent version of the Uniform Administrative Procedures of the Interstate Industrialized Building Commission, to update the history, and to comply with state law. The proposed amendments address adoption of the 2018 UAP of the IIBC which administers the Third Party Inspection Program for the state and removes sections which have language covered under the UAP. The amendments also reflect the language contained in NDCC 54-21.3-07. The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000.
