**FULL NOTICE OF INTENT TO
AMEND ADMINISTRATIVE RULES
67-13-01 School District Cooperative Agreements**

TAKE NOTICE that the North Dakota Department of Public Instruction (NDDPI) will hold a public hearing to address proposed amendments to North Dakota Administrative Code 67-13-01 at 10:00 a.m. on Wednesday, July 5, 2017, at 600 East Boulevard Avenue, State Capitol, Bismarck, ND, in the Peace Garden Room located on ground floor. The purpose of the proposed amendment is to clarify and update obsolete rules and to ensure compliance with North Dakota Century Code (NDCC) 15.1-27-16. The proposed rule is not expected to have an impact on the regulated community in excess of \$50,000.

The proposed rules may be reviewed at the NDDPI, Office of School Finance and Organization, ND State Capitol, 600 E. Boulevard Ave, Bismarck, ND, 58505-0440.
