**FULL NOTICE OF INTENT TO
AMEND AND CREATE NEW ADMINISTRATIVE RULES RELATING TO
SCHOOL CONSTRUCTION LOAN APPLICATION AND LOAN APPROVAL**

TAKE NOTICE that the North Dakota Department of Public Instruction (NDDPI) will hold a public hearing to address proposed changes to N.D. Admin. Code 67-10 School Construction Loan Application and Loan Approval at 10:00 a.m. on Thursday, August 10, in the Fort Union Room, ground floor, State Capitol, 600 East Boulevard Avenue, Bismarck, ND, 58505-0440. The purpose of the proposed changes is to repeal 67-10-01 School Construction Loan Application and Loan Approval; to create 67-10-02 School Construction Loan Application and Loan Approval – Coal Development Trust Fund; to create 67-10-03 School Construction Loan Application and Loan Approval – School Construction Assistance Revolving Loan Fund. These changes are necessary to implement amendments made by the 65th Legislative Assembly to North Dakota Century Code (NDCC) 15.1-36-02 and NDCC 15.1-36-08. The proposed rules address loan eligibility requirements and issuance of construction loans necessary to implement SB 2272, enacted during the most recent legislative session. The proposed rule is not expected to have an impact on the regulated community in excess of \$50,000.

The proposed rules may be reviewed at the NDDPI, Office of School Finance & Organization, ND State Capitol, 600 E. Boulevard Ave, Bismarck, ND, 58505-0440. A copy of the proposed rules and/or a regulatory analysis may be requested by writing to the above address, to the attention of Don Williams, e-mailing dmwilliams@nd.gov or calling 701-328-2236. Written or oral comments on the proposed rules sent to the above address or telephone number and received by 4:00 p.m. on Wednesday, August 23, will be fully considered.
