NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES
RELATING TO 67-17-01 ADULT EDUCATION AND LITERACY PROGRAMS

TAKE NOTICE that the North Dakota Department of Public Instruction (NDDPI) will hold a public hearing to address proposed amendments to North Dakota Administrative Code 67-17-01, Adult Education and Literacy Programs, at 10:00 a.m. on Tuesday, September 29, 2015, in the Fort Totten Room, State Capitol, 600 East Boulevard Avenue, Bismarck, ND 58505-0440. The purpose of the proposed amendment(s) is to bring current rules up to date and to delete obsolete and unnecessary language. The proposed amendment(s) redefine the purpose of adult education, eliminates references to adult literacy, and cites most current federal regulation authorizing adult education. The proposed amendment(s) is not expected to have an impact on the regulated community in excess of \$50,000.

The proposed rules may be reviewed at the office of the NDDPI, 11th Floor, State Capitol, 600 East Boulevard Avenue, Department 201, Bismarck, ND, 58505-0440.
