## **NOTICE OF INTENT TO ADOPT, AMEND AND REPEAL ADMINISTRATIVE RULES**

TAKE NOTICE that the North Dakota Game and Fish Department will hold a public hearing to address proposed new rules AND amendments to Title 30 of the North Dakota Administrative Code, at 1:15 P.M. on Thur., June 15, 2017 at 100 North Bismarck Expressway, Bismarck, ND. The purpose of the proposed rule changes is to implement statutes. The proposed rules changes are not expected to have an impact on the regulated community in excess of \$50,000.

The purpose and an explanation of the proposed rule changes follow:

### **Chapter 30-05-02 Watercraft for Hire [Repealed]**

**Chapter 30-03-03 – Construction and Use of Fishhouses For Winter Fishing.** An amendment to section 30-03-03-03, to add the use of allowing ‘a registration number issued by the department’ for identification on the fishhouse.

**Chapter 30-04-02, Section 30-04-02-05. Firearms.** An amendment to add rules for shooting ranges on wildlife management areas.

**Chapter 30-04-02, Section 30-04-02-14.1. Tree Stands, Ground Blinds, Game Cameras, and Traps.** An amendment to include the use of game cameras and the identification of game cameras and traps.

**Chapter 30-04-02, Section 30-04-02-22 – Drones Prohibited.** An amendment to adopt a new section to prohibit the use of drones on state wildlife management areas.

**Chapter 30-02-05 – License Raffles & Auctions.** An amendment to replace this chapter’s title and context with language that combines rules for all raffles and auctions and repeals other related chapters.

### **Chapter 30-02-06 – Moose License Raffle [Repealed]**

**Chapter 30-02-07 – Mule Deer License Raffle [Repealed]**

**Chapter 30-02-08 – Antelope License Raffle [Repealed]**

**Chapter 30-02-09 – Elk License Raffle [Repealed]**
