NOTICE OF INTENT TO
ADOPT AND AMEND ADMINISTRATIVE RULES
Relating to Pari-Mutuel Wagering Systems and the North Dakota Breeders' Fund

TAKE NOTICE that the North Dakota Racing Commission will hold a public hearing to address a proposed new rules and amendments to N.D. Admin. Code articles 69.5-01-08 Pari-Mutuel Wagering Systems and 69.5-01-09 North Dakota Breeders Fund at **9:00 a.m. on Tuesday, April 3, 2018 at the ND Racing Commission Office, 500 North 9th Street (lower level), Bismarck, North Dakota.**

The purpose of the proposed rule and amendments are to amend and establish regulatory requirements and clarify rules. The proposed new rules modify the requirements for tournament wagering and clarify that the breeder an accredited North Dakota bred is entitled to the dam's Breeders' Fund awards. The proposed rule and amendments are not expected to have an impact on the regulated community in excess of \$50,000.
