NOTICE OF INTENT TO
ADOPT AND AMEND ADMINISTRATIVE RULES
Relating to the Race Officials, Licensees, Conduct of Races,
Simulcasting and Account Deposit Wagering

TAKE NOTICE that the North Dakota Racing Commission will hold a public hearing to address a proposed new rules and amendments to N.D. Admin. Code articles 69.5-01-03 Race Officials, -05 Licensees, -07 Conduct of Races, and -11 Simulcasting and Account Deposit Wagering at **9:00 a.m. on Monday, December 4, 2017 at the ND Racing Commission Office, 500 North 9th Street (lower level), Bismarck, North Dakota.**

The purpose of the proposed rule and amendments are to amend and establish regulatory requirements and clarify rules. The proposed new rules and amendments codify stewards' inquiry procedures, modify jockey requirements, revise starter and loading requirements, and modify the customer verification process for social games. The proposed rule and amendments are not expected to have an impact on the regulated community in excess of \$50,000.
