## NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota State Board of Psychologist Examiners will hold a public hearing to address proposed amendments to N.D. Administrative Code 66-01-01-01, 66-02-01-01, 66-02-01-03, 66-02-01-03.1, 66-02-01-06, 66-02-01-07, 66-02-01-07.1, 66-02-01-08, 66-02-01-09.1, 66-02-01-10, 66-02-01-13, 66-02-01-14, 66-02-01-15, 66-02-01-16, 66-03-01-01, 66-03-01-04, 66-03-01-05, 66-03-01-06, at 4:00 pm on Friday, September 27, 2019 at Badlands Human Service Center, 300 13th Ave W, Ste. 1, Dickinson, ND 58601 Basement Meeting Room. The purpose of the proposed amendments is to implement changes made in Century Code and make administrative code clearer by providing more efficient procedures. The proposed rule addresses: 66-01-01-01 removes reference to behavior analysis and updates contact information, 66-02-01-01 removes reference to registration only pertinent to behavior analysts, 66-02-01-03 removes reference to behavior analysts, 66-02-01-03.1 adds military spouse licensure from SB2306 , 66-02-01-06 removes behavior analyst reference, 66-02-01-07 removes behavior analyst reference, 66-02-01-07.1 removes behavior analyst reference, 66-02-01-08 removes behavior analyst reference, 66-02-01-09.1 removes behavior analyst reference, 66-02-01-10 removes behavior analyst reference, 66-02-01-13 removes behavior analyst reference, 66-02-01-14 removes behavior analyst reference, 66-02-01-15 removes behavior analyst reference by repealing section, 66-02-01-16 removes behavior analyst reference, 66-03-01-01 removes behavior analyst reference, 66-03-01-04 removes behavior analyst reference, 66-03-01-05 removes behavior analyst reference, 66-03-01-06 removes behavior analyst reference. The proposed rulemaking implements bills numbered SB 2236 and SB2306, enacted during the most recent legislative session, concerning the State Board of Psychologist Examiners. The proposed amendment is not expected to have an impact on the regulated community in excess of \$50,000.
