# House Bill No. 1020 - Other Changes - House Action

This amendment provides for a study of industrial hemp and authorizes the Main Research Center to contract with any other university for the procurement of hemp seed necessary to conduct research.

This amendment provides carryover authority for the research greenhouse complex at the Main Research Center funded with bond proceeds (\$2 million) and gifts, grants, and donations (\$5 million) and for the North Central Research Center laboratory and greenhouse project funded with bond proceeds (\$440,000) and gifts, grants, and donations (\$1,250,000). These projects were authorized by the 2005 Legislative Assembly. In addition, references to phase 1 and phase 2 of the greenhouse project at the Main Research Center are removed. The Main Research Center may use any funding available within the total appropriation authority for the Main Research Center greenhouse project to begin construction. The total appropriation includes the carryover authority of \$7 million and 2007-09 biennium authority of \$7 million from the general fund.

Amends North Dakota Century Code Section 24-02-03.3 to exempt certain vehicles used in farming operations at the Agronomy Seed Farm and branch research centers from state motor pool requirements.

This amendment includes a section identifying one-time projects and for a report to the Appropriations Committees of the 61st Legislative Assembly regarding the use of this one-time funding.
