

Other Sections in House Bill No. 1020

Additional income - Section 3 appropriates, subject to Budget Section approval, any additional federal or other funds available to the State Water Commission during the 2021-23 biennium.

Exemption - Water-related projects - Section 4 authorizes the State Water Commission to continue unexpended funds of \$22,000,000 in capital assets and \$295,363,183 in project carryover into the 2021-23 biennium.

Carryover funding reports - Legislative Management - Section 5 creates a new section to North Dakota Century Code Chapter 61-02 to require the State Water Commission to report on carryover projects to the Legislative Management on a quarterly basis.

Line of credit authorization - Section 6 extends authorization of a line of credit for the State Water Commission at the Bank of North Dakota, not to exceed \$75 million, at a rate of 1.5 percent over the 3-month London interbank offered rate (LIBOR).

Western Area Water Supply Authority - Revenue bonds - Section 7 creates a new section to Chapter 61-40 authorizing the Western Area Water Supply Authority to issue revenue bonds.

Pilot project - Implementation of a basinwide plan - Section 8 identifies that of the \$1.1 million appropriation for basinwide implementation, up to \$1 million is for grants to water resource districts to develop basinwide water plans and up to \$100,000 is for grants for local administrative costs associated with the implementation of a basinwide plan.

Directive - Fargo flood control project - Legislative intent - Section 9 limits total state funds that may be approved by the State Water Commission for the Fargo flood control project to not more than \$850 million and provides legislative intent the state provide a portion of the local cost-share of the Fargo flood control project not to exceed \$850 million. The section provides legislative intent that of the \$850 million, the state has provided \$414.5 million and the remaining \$435.5 million is to be provided from bond proceeds during the 2021-23 biennium.

Directive - Mouse River flood control project funding - Legislative intent - Section 10 provides that excluding funding provided for Mouse River flood control projects prior to the 2021-23 biennium, total state funds that may be approved by the State Water Commission for Mouse River flood control may not exceed a total of \$604 million. The section provides legislative intent that of the \$604 million, \$74.5 million is provided from the resources trust fund.

Legislative intent - Rural water supply - Section 11 provides legislative intent that in addition to any funds approved for the project prior to the 2021-23 biennium, up to \$1.6 million of the funding appropriated in the rural water supply grants line item be made available during the 2021-23 biennium to the system 4 connection to system 1 rural water supply project sponsored by All Seasons Water District.

Legislative Management study - Red River Valley Water Supply Project management - Section 12 provides for a Legislative Management study in conjunction with input from the State Water Commission and stakeholders of the Red River Valley Water Supply Project of an entity to own, manage, and operate the project.

Legislative Management study - Northwest Area Water Supply Project - Section 13 provides for a Legislative Management study with input from the State Water Commission, of an entity, other than the state, to own, manage, and operate the Northwest Area Water Supply Project.

Emergency - Section 14 declares the bill to be an emergency measure.

Continuing Appropriations

Infrastructure revolving loan fund - North Dakota Century Code Section 61-02-78 established the infrastructure revolving loan fund within the resources trust fund to provide loans for water supply, flood protection, or other water development and water management projects. A total of \$26 million of oil extraction money was deposited in the resources trust fund and, along with loan repayments and earnings of the fund, is available on a continuing basis for infrastructure loans.

Deficiency Appropriation

There are no deficiency appropriations for this agency.

Significant Audit Findings

The following two significant audit findings were identified in the agency's audit ending June 30, 2019:

- Improper emergency action plan process for dams
- · Dam operating plans are not being tracked or reviewed

Major Related Legislation

House Bill No. 1063 - Amends Sections 61-24.6-02 and 61-24.6-10 relating to the membership on the Northwest Area Water Supply Advisory Committee and the areas to be served by the Northwest Area Water Supply Project.

House Bill No. 1353 - Creates a director position and renames the Office of the State Engineer to the Department of Water Resources.

House Bill No. 1431 - Combines the community water development fund and the infrastructure revolving loan fund within the resources trust fund into the water infrastructure revolving loan fund. The bill also provides funds from bonding to repay \$74.5 million to the resources trust fund for outstanding debt of the Western Area Water Supply Authority and appropriates \$74.5 million from the resources trust fund to the State Water Commission to provide grants for Mouse River flood control projects. The bill also provides \$435.5 million of bond proceeds for the Fargo diversion project.

House Bill No. 1437 - Creates Section 61-32-03.2 relating to small subsurface water management systems, provides for the permitting of subsurface water management systems and provides for cost-share from the State Water Commission.

Senate Bill No. 2081 - Amends Sections 61-16.2-06 and 61-16.2-08 relating to permissible uses in the floodway and flood fringe under the national flood insurance program.

Senate Bill No. 2208 - Provides for a Legislative Management study of water regulation in the state.

Section 3 would appropriate any additional income from the resources trust fund or water development trust fund that becomes available to the State Water Commission during the 2021-23 biennium.

Section 3 provides that in addition to the amounts appropriated to the State Water Commission from the resources trust fund, any additional amounts that become available in the fund are appropriated, subject to Budget Section approval, to the State Water Commission for the purpose of defraying the expenses of the State Water Commission for the 2021-23 biennium.



SECTION 3. ADDITIONAL INCOME - APPROPRIATION. In addition to the amounts included in the estimated income line item in section 1 of this Act, any additional amounts in the resources trust fund that become available are appropriated to the state water commission for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2021 and ending June 30, 2023.

SECTION 4. GRANTS - WATER-RELATED PROJECTS - CARRYOVER AUTHORITY. Section 54-44.1-11 does not apply to funding for grants or water-related projects included in the capital assets, project carryover, water supply – grants, rural water supply – grants, Fargo area flood control including the Fargo Moorhead diversion, Mouse River flood control, flood control projects other than Fargo area flood control including the Fargo Moorhead diversion, and general water – grants line items in section 1 of this Act. However, this exclusion is only in effect for two years after June 30, 2023. Any unexpended funds appropriated from the resources trust fund after that period has expired must be transferred to the resources trust fund.

SECTION 5. LINE ITEM TRANSFERS. The chief engineer/secretary of the state water commission may transfer between the salaries and wages, operating, capital assets, project carryover, water supply – grants, rural water supply – grants, Fargo area flood control including the Fargo Moorhead diversion, Mouse River flood control, flood control projects other than Fargo area flood control including the Fargo Moorhead diversion, and general water – grants line items in Section 1 of this Act when it is cost-effective for construction of water projects. The state water commission shall notify the office of management and budget of any transfers made pursuant to this section.

SECTION 6. AMENDMENT. Section 61-02-79 of the North Dakota Century Code is amended and reenacted as follows:

61-02-79. Bank of North Dakota - Line of credit. The Bank of North Dakota shall extend a line of credit not to exceed seventy-five million dollars at a rate of one and one-half percent over the three month London interbank offered rate but may not exceed three percent to the state water commission. The state water commission shall repay the line of credit from funds available in the resources trust fund or other funds, as appropriated by the legislative assembly. The state water commission may access the line of credit, as necessary, to provide funding as authorized by the legislative assembly for water supply projects approved before June 30, <u>20212023</u> and flood control projects that have approval for funding before June 30, <u>20212023</u>.

SECTION 7. BANK OF NORTH DAKOTA LINE OF CREDIT. The sum of \$75,000,000, or so much of the sum as necessary, from a Bank of North Dakota line of credit included in section 6 of this Act, may be transferred to the state water commission for the purpose of funding water projects for the biennium beginning July 1, 2021 and ending June 30, 2023.
