If House Bill 1257 is enacted as amended, the State's General Fund portion of the coal severance tax would be decreased by \$2,061,000 in the 1979-81 Biennium.
The Coal Impact Office would be <u>decreased</u> by \$2,405,000. The trust portion would be <u>decreased</u> by \$1,031,000 and the coal producing counties portion would be <u>decreased</u> by \$1,374,000 during the 1979-81 Biennium.
