Madam Speaker and members of the Assembly: I would like to speak briefly to the issue which just passed and to explain, I think, why some members voted no, including myself.

This was in no way a reflection against a very fine institution of higher learning, nor was it in any way a reflection against the individuals who sponsored and worked very hard for this name change and for the passage of this bill.

I think that we in North Dakota need to have an overview of all of higher education. I would have preferred, and I think others would have preferred, if the Board of Higher Education had brought in a report which would tell us what they think we should have in the state of North Dakota, not

only for 1983, but for ten years from now and maybe even twenty years from now.

We are a small state. I tend to think that we are at the crossroads with regard to higher education. We have other institutions and they also are fine institutions, at Dickinson, at Valley City, and at Mayville. We have junior colleges and we have only about 650,000 people.

- I do believe that a number of individuals who voted no did so because they want to know what the plan is for the future and what the program is for the future and where all of the institutions and all of the curriculums come together in some type of a comprehensive plan for the people of North Dakota.
- I have great respect for the administration of Minot college and I certainly, as always, stand strongly to support education.

## POINT OF PERSONAL PRIVILEGE

REP. O. HANSON: Madam Speaker: I rise to a point of personal privilege and request that my remarks be printed in the Journal.

There is about a million dollars that we are taking out of the general fund and putting in above the budget. The total amount of money spent for agricultural research and experimentation here in the state of North Dakota, which includes the extension service and Northern Crop Institute, totals about sixty million dollars.

This morning we passed a higher education bill out of here, amounting to over two hundred million dollars. We will, before we finish here, spend about two hundred and twenty-five million for elementary and secondary education, and better than two hundred million for human and social service. The money has to come from somewhere to pay the taxes to support these bills.

It has been stated on the floor many times that from fifty-five to sixty-five percent of all revenue in the state of North Dakota comes out of agriculture, and in return about four percent goes back.

If you go out of here and talk to the farmers in the rural areas you will find that the first thing they want you to do is cut the budget. If you can't do that, then you will have to raise the taxes, but at least give us something tangible for what we have.

The farmers have felt for many, many years that they are getting the short end of it relative to the rest of the budget. All you have to do is take a look at the Appropriations Committee and see how it is overloaded with city legislators as versus rural legislators. They don't mind paying these taxes. They'll pay that extra cent in sales tax and they will pay that gas tax. They'll pay that

extra income tax, if you give them something in return and they can see it.

For example: They can see it in the research stations in North Central at Minot, the cleaning plant, one of the biggest providers of pure seed we have in the state of North Dakota which is an antiquated cleaning plant.

The farmers can see the results of that. They can see the results at Hettinger and the new agronomist and technician, also better grades of sheep and better grades of winter wheat at Dickinson, the cowboys can see it in their cattle and the statistics and better grasses that come out of the Central Grasslands at Streeter. Langdon is the same way. This is the way it is all down the line.

They can see all this but if you will give them that, they aren't going to be so apt to growl when they have to pay the taxes to foot all the rest of that bill. I'd certainly encourage you to agree on this bill.
