## STATEMENT OF PURPOSE OF AMENDMENT:

# Public Instruction

The salaries and wages line item is reduced by \$3,344, of which \$1,299 is from the general fund and \$2,045 is from other funds. This will allow funds for average salary increases of 5.5 percent the first year of the biennium (these funds are to continue the cost of an average increase of 5.5 percent on May 1, 1985) and average salary increases of four percent the second year of the biennium. Funds are allowed to provide a minimum increase of \$50 per month for each year of the biennium. The salary increases are to be based on merit, performance, or equity adjustments, and are not intended to be across-the-board salary increases.

The salaries and wages line item is further reduced by \$98,644, of which \$38,334 is from the general fund and \$60,310 is from other funds, to delete funds for the following 2.65 FTE positions: 1 FTE Clerk-Typist II, 1 FTE Clerk Stenographer II, .5 FTE Program Coordinator, and .15 FTE Program Director.

The operating expenses line item is reduced by \$107,000 from the general fund and the equipment line item is reduced by \$3,500 from the general fund.

Sections 2 and 3 of the bill are deleted. This deletes the general fund appropriation of \$50,000 for a teacher compensation

study and deletes the \$2,000,000 general fund appropriation for matching grants for computer purchases.

A new grants line item entitled "Grants - boarding care" is added in the amount of \$1,229,844 from the general fund to provide for the Department of Public Instruction to pay for boarding care costs for special education students placed outside their district. Corresponding decreases of the same amount will be made to the Department of Human Services appropriation in House Bill No. 1009 to reflect a transfer of responsibility for these costs from Human Services to Public Instruction.

The special education line item is reduced by \$1,481,356 from the general fund to provide funding at 33 percent of the personnel costs (allowing for 1983-84 personnel levels with five percent per year salary increases) and providing for 41 additional instructors for the three- to five-year-old program. The grants - foundation aid line item is reduced by \$14,360,206 from the general fund to reflect the following:

- 1. Per-pupil payments of \$1,370 in 1985-86 and \$1,475 in 1986-87, based on weighted units of 127,584 in 1985-86 and 129,655 in 1986-87.
- 2. Tuition fund distribution of \$47,895,000 in 1985-87, which reflects estimated payments of \$195 per census unit in each year of the biennium (same as in original executive budget).
- 3. Total transportation payments of \$37,802,514, which is based on the current transportation rates less a reduction for a provision that no school district may receive payments in excess of an amount equal to 100 percent of that school district's average annual transportation costs incurred during the previous five school years.
- A total 20-mill deduct of \$40,368,473, which is \$2,063,527 less than estimated in the original executive budget.
