I'm especially proud that our school system is one in which three small towns, Maxbass, Newburg, and Kramer, have joined together to form one very excellent school, both academically and in their sports and music programs. The people in those communities realized that we could merge to form one system with very little difficulty and hard feelings.

- 3. No personal property belonging to such estate shall be sold within five years from the date upon which the patient was sent to the state school unless such property is ordered sold by the county court having jurisdiction of the estate for the reason that such property is

likely to deteriorate in value during the time herein specified.

4. No claim shall be made to recover from the estate of a former resident of the state school who has left the state school and married, and leaves a spouse or issue dependent upon such estate.

SECTION 6. A new section to chapter 25-04 of the North Dakota Century Code is hereby created and enacted to read as follows:

Waiver of payment - Use of income tax data - Confidentiality - Definition.

former personal patient, patient, representative, or guardian may make application to the supervising department to pay less than the costs or none of the costs incurred by the state for the patient's care and treatment at the state school.
