FIRST DAY

POINT OF PERSONAL PRIVILEGE

We now have our first woman Lieutenant Governor, and Madam President, on behalf of the Democrat Caucus, and I think all of the Senate, the people of North Dakota, we welcome you to the North Dakota Senate, and we are very proud to have you here.
