REMARKS

By Honorable Mark Andrews United States Senator

Thank you Madam President. It's a privilege to be here. I always make mistakes, though, coming up here and that natural urge to go to the left, but my friends corrected me, and I went to the right. Actually, it's good to see so many old friends here. To those of you who are the party I belong to, the Republican Party; we've campaigned together in your homes and your communities so often, it's like seeing part of the family. Earl Kelly and I go back a long, long time, even longer than some of the old mossback members of the Senate. To those of you on the opposite side of the political aisle, of course, we get a great affinity for you too, because as we go down to your neighborhoods, often we see you working the other side of the street and we understand each other completely because even though we may be from separate parties, we're both working for the same state and the same group of people, and that's really what government and politics in this country of ours is all about. The challenges, Madam President, that we face down at the federal level are not too far different from the challenges

that you face out here in our state legislature. Actually, our problems are those of revenue and spending and they're the same things that you're faced with on a day-by-day basis out here. You've got an advantage because you've got a balanced budget requirement and there's no way you can slip, slide, and duck around that one and end up with a gross deficit that impacts so unfavorably upon the people. That federal deficit that's running this last year at a \$180 billion, projected next year to not be much different, has a tremendous adverse impact on agriculture. As a farmer myself, not just as a member of the Senate Ag Committee, I know what we need in agriculture. We need higher prices and we need lower interest rates. That's the best kind of farm program we could get. And they're both impacted and impacted adversely by this deficit. Now how do we get the deficit under control? Well, that's the challenge that we face. But the only way we're going to get it under control is when enough people realize what it's doing to them. The deficit for years has been a kind of a dirty word--something to be avoided. But until the general public feels that blowtorch of the effects of the deficit on their rear, they're not going to be pushed into demanding that we do something about it.

Think for just a minute about what the deficit does do to us. Last year we had to get \$80 billion from foreign investors to cover the deficit we were unwilling to cover ourselves. How do we get that money from foreigners? We get it by urging it in, by coaxing it in. We get it by super valuing the dollar and kiting interest rates higher than they are in competitive economies in this world of ours. And because we did that, we got the money in. And you could read in your newspapers on the weekend, travel plans--buy a ticket to Europe, ski in the Swiss Alps; it's a wonderful bargain. It is? It's a bargain today because of the super value of the dollar to eat at a fancy French restaurant, or stay in a British hotel, but it's not worth a darn if you want to sell a bushel of wheat overseas, and we have to sell three out of every five bushels of grain we produce overseas in order to find a market for them. That's part of the impact on agriculture. For year after year after year, we've been talking about the deficit and doing nothing about it. I'm extremely proud that an idea that we have to freeze spending is gaining support. It's a bipartisan concept. Senator Hollings is the principal Democratic sponsor, I'm the principal Republican sponsor. My colleague, Senator Burdick, supports it as I do. Last year we got thirty-eight votes. Why is it better than some of the other ideas? Let me share with you for just a minute why I think it's better. Davy Stockman's hit list is just that: a hit list, maybe you'd call it a wish list. Who's going to vote to cut \$500 million from the National Institute's of Health research program to find ways of curing cancer, heart disease, and stroke? Name five members of the Senate. You can't find them. Who's going to vote to cut out money for women, infants, and children nutrition? The WIC program, the one that supplies money to take care of the adequate nourishment of the pregnant woman? You know if you don't care about people; if you're flinty-eyed and mean and you could care less about humanity and you only worship the dollar, you still ought to be for that program because every dollar you spend in adequate nutrition for a pregnant woman saves you four dollars that you don't have to spend taking care of the handicapped child. AMTRAK, important to North Dakota's northern tier of states--AMTRAK, Dave Stockman comes out and says we're going to save \$684 million by cutting out AMTRAK. What they don't look at is we've got to spend \$2.10 billion in canceled labor contracts if we cut out AMTRAK. That's not a saving, that's costing.

And then you've got to look at the phony figures they use. You've read in the newspaper about AMTRAK should go because with AMTRAK the federal government is subsidizing \$36 of every ticket purchased on AMTRAK. I checked into that and I found it's true. But as Chairman of the Transportation Subcommittee, I checked into how much the federal government subsidizes airline tickets and I found that for every airline ticket that's purchased, there's a federal government subsidy of \$39. Is it bad then for a federal government subsidy of \$36 for a railroad ticket, but not bad for a federal subsidy of \$39 for an airline ticket? I think not.

These are the things that we have to look at. The challenge then if these programs are there because they've been adopted because of public hearings where people from all over this great land of ours have come and testified, they've been passed on by bipartisan committees of the Congress, adopted by both houses, signed by the President, they're probably there because they're needed. Then the only way really to address the deficit is to do it in some concrete way and that concrete way is an across-the-board freeze. As I said, as the principal Republican sponsor joined with Senator Hollings, principal Democratic sponsor, joined also by my colleague, Quentin Burdick, we're proud that we are gaining ground on that freeze. This week's edition of Newsweek in Periscope mentions it and how we're gaining ground.

Why do we need a freeze? We need a freeze because \$300 billion of our spending is in defense, \$250 billion is entitlements, and another \$150 billion is interest on the national debt - that's \$700 billion. And if you increase defense spending, hold harmless and let rise entitlements, then you obviously can't do anything about the \$150 billion interest on the debt. It's idiotic to think that you can save \$200 billion which is the deficit out of the remaining \$275 billion of the federal budget. because that's really the investment part of the budget. It's the part that builds the highways, does the farm research and runs the Soil Conservation Service, and funds the water projects and the rest. But we're making progress and we think we're going to get a solid vote on a budget freeze and get to the point where we can, in fact and in deed, say that we have held the deficit finally under control, and we're going to do it on a bipartisan basis. Closer to home, of course, those deficits have caused a farm credit crunch. You're wrangling with how to handle that in the Legislature. We're challenged by how to handle it on the federal level because it's really a federal problem. I held three hearings across North Dakota as Chairman of the Subcommittee on Investigations with the Senate Agriculture Committee last summer. Those hearings showed me conclusively that credit problems were growing across my home state of North Dakota. When I checked with my colleagues, I find those in other agricultural areas were having the same problems. We were able last fall to pass a credit emergency bill: a \$650 million pilot loan guarantee program. It was passed, it was signed into law and it's what the President implemented just a week and a half ago. It's a beginning, but it's just a beginning. With that money released and with teams out in the field helping implement it with the local bankers and with, and mind you this is a figure you ought to be aware of, the operating loan window of Farmers Home this year has two and a half times as many dollars available as they had just four years ago. Farmers Home is not being shorted money. The need of agriculture has grown and grown at a pace that no one could imagine.

The other part of the President's initiative and one that we hope we can broaden is the instructions that they're giving to the bank examiners when they go to those local banks: tell them be a little sensible about how you handle farm loans. You know in the last few months bank examiners have been looking at the financial statement of farmers, and they've said this machinery isn't worth what it says on the statement. These acres aren't worth what they were when you put them on the statement. And even though the individual customer, that farm family is up-to-date in their interest payments and up-to-date in their loan principal payments, the bank examiner, because of technical rules enforced in a way that had they been enforced thirty years ago, I couldn't have gotten my start in farming, has asked the bank to classify the loan and begin to proceed against it. We have to stop that by instructing the bank examiners to use a little common sense and judgment and make sure that these financial statements aren't classified for reasons over which that farm family had no control at all.

Now people might ask why we're that concerned. Is this a legitimate object of government to do this? I say yes. I'm here talking today out of your generous hospitality, Madam President, and I recognize I don't want to impose too much on your time, but I'm here as my colleague, Byron Dorgan, was earlier this week because we're now on a Lincoln Day recess. They've turned us loose for ten days, that means you can relax, we're not going to do anything to you for at least ten days. But it also means we have time to come back home and celebrate the birthday of the individual who gave birth to our great Republican Party. We're going to have a Lincoln Day dinner in town tonight and I know most of my Republican friends in this chamber will be there, and I want to extend a most cordial welcome to my Democratic friends in this chamber to come too. You might learn quite a bit from our talking about Abraham Lincoln and what he has to offer, and we'd be very happy to have you and I'm sure that we Republicans would show you a very warm welcome. But let me get back to why we should be concerned about agricultural credit in the terms of Lincoln and what he stood for.

Lincoln's belief basically was in the Constitution. Many people forget what's in that document. Lincoln believed in the constitutional responsibility of government to ensure domestic tranquility and to promote the general welfare. That led him to proclaim his oft-repeated words that the legitimate object of government is to do for a community of people whatever they need to have done but cannot do for themselves in their separate and individual capacities. That was good doctrine over one hundred and twenty years ago, and it's good and necessary and needed doctrine today. And that's why we have to move ahead to sensibly resolve the farm credit crunch that bothers our nation so deeply.

So, in this tradition, we're addressing the need. It is, in deed and in fact, critical to our nation's future, and I as one farmer, more so probably than as a legislator, would hope that we can begin talking about farm programs, not from the standpoint of the farm problem, but from the standpoint of the agricultural opportunity. Think for just a minute in a world that's troubled and wondering which side to stand with, in a world where wheat moves at \$10 a bushel in Europe and costs \$12 a bushel to produce in the Soviet Union, costs \$29 or \$30 a bushel to produce in the People's Republic of China and the Japanese support it at \$27 a bushel. We produce it in abundance for three dollars and a half and call it a farm problem. And yet we see on our television screens the searing hunger in lands like Ethiopia. We take a look at the military problems we have in Central America and wonder how we can address them and the military problems down there came about because the infrastructure of that country fell apart because of a lack of adequate nutrition. Any four-year farm bill we put together, I would hope, would be put together not on the basis of addressing the farm problem, but speaking to the agricultural opportunity and what it can give our nation in the leadership of a troubled world in proving that our system works so much better than any other system because it can produce that basic commodity, that basic need of mankind, food, and have enough left over to share with others at reasonable cost. This really is the pride of America. This is why it's so important to get our farm credit needs under control before spring planting season and to move on with pride to salute and look up to what our farm families have given us that we have overlooked decade after decade, through administration after administration. Let me assure you that I understand the South Dakota's legislature is coming down to Washington; they're taking up a collection down there to have them come down. The weather isn't all that good in Washington, but speaking on behalf of Quentin and Byron, we can assure you warm hospitality if you do come down and we'll be glad to have you. Let me also say that Quentin joined me last fall in putting together that \$650 million pilot program for farm credit, and Byron, I understand, is now having farm hearings around North Dakota. He's going to find out what I found out last summer, that indeed there is a problem out there, so we're convinced. But if you want to come down and convince us more, I can't tell you how happy we'd be to see those friendly faces that I'm looking at right now to come down, so look upon it as an invitation if you choose. Otherwise, we'll count you on our side when we work to take care of this farm credit crunch that affects us so much.

Let me say just one other thing. I spoke early on of the advantage you have as North Dakota legislators, because you work, Madam President, under a Constitution that doesn't allow you to run a deficit. You have the other advantage of having a date certain for ending your legislative session. That means that bills and problems and the rest all must be dealt with in a timely manner. That also means that those of us who have been given your gracious hospitality can return it most effectively by not leaning on it for too long a period of time so that you can, in deed and in fact, get on with the job.

Thanks for including me here today with you. Best wishes to what you are doing for the state of North Dakota. It's a privilege to work with and for you. We appreciate your hospitality.

SECTION 1. AMENDMENT. Section 15-28-09 of the 1983 Supplement to the North Dakota Century Code is hereby amended and reenacted to read as follows:

15-28-09. Election - Candidates - Ballots - Stickers. Any

- Except as otherwise provided in subsection 2, any candidate for election as a member of the school board of a school district shall file with the clerk of the board, not less than twenty-five days before the election and before four p.m. on the twenty-fifth day, a statement setting forth the candidate's name and the position for which that person is a candidate. A statement which is mailed to the clerk shall be in the clerk's physical possession before four p.m. on the twenty-fifth day before the election. At least twenty days before the election, the clerk shall prepare and cause to be printed, or otherwise uniformly reproduced, an official ballot filed as herein provided. The arrangement of the names of the candidates upon the ballot shall be determined by lot by such clerk in the presence of the candidates or their representatives. The ballot shall be headed "official ballot", shall nonpartisan in form, and shall contain the be following:
 - 1- a. The name of the district.
 - 2- b. The date of the election.
 - $3- \underline{c.}$ The number of persons to be elected to each office.
 - 4- <u>d.</u> Blank spaces below the names listed as candidates for each office in which names not stated on the ballot may be written.
- 2. When a school annual election or special election is held in conjunction with a statewide election,

any candidate for election as a member of the school board of a school district shall file with the clerk of the board, not less than fifty-five days before the election and before four p.m. on the fifty-fifth day, a statement setting forth the candidate's name and the position for which that person is a candidate. A statement which is mailed to the clerk shall be in the clerk's physical possession before four p.m. on the fifty-fifth day before the election.

3. Nothing herein shall prevent any person who is qualified to hold the office, who desires to be a candidate at the election, and who has failed to file as herein provided, from providing stickers to be attached to the official ballot by the electors. A sticker shall not be more than onehalf inch [12.7 millimeters] in width, and shall have printed thereon the name and address of one person."
