- 1 A BILL for an Act to create and enact two new sections to chapter 15-39.1 of the North Dakota
- 2 Century Code, relating to the composition and administrative authority of the teachers' fund for
- 3 retirement board; to amend and reenact section 15-39.1-07 and subsection 1 of section
- 4 54-07-01.2 of the North Dakota Century Code, relating to vacancies on and appointments to the
- 5 teachers' fund for retirement board; and to repeal section 15-39.1-05 of the North Dakota
- 6 Century Code, relating to management of the teachers' fund for retirement.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. Two new sections to chapter 15-39.1 of the North Dakota Century Code are created and enacted as follows:

Board composition - Terms - Voting.

- The authority to set policy for the fund rests in a board of trustees composed as follows:
 - a. Two board members elected by and among the active participating members of the fund who are actively employed in full-time positions not classified as school administrators. A board member elected under this subdivision who terminates employment may not continue to serve as a member of the board.
 - b. One board member elected by and among the active participating members of the fund who are actively employed as full-time school administrators. A board member elected under this subdivision who terminates employment may not continue to serve as a member of the board.
 - c. Two board members elected by and among the retired members of the fund.
 - d. The state treasurer and the superintendent of public instruction.
- 2. All current appointees of the board shall serve the remainder of their term as members of the board until their terms expire and their successors are elected.

The board may adopt such rules as may be 18 necessary to fulfill the responsibilities of the board. 19 **SECTION 3.
