- 1 A BILL for an Act to create and enact chapter 54-24.4 of the North Dakota Century Code,
- 2 relating to the North Dakota library coordinating council; to amend and reenact sections
- 3 54-24-02, 54-24-03, 54-24-09, 54-24.3-01, 54-24.3-03, 54-24.3-04, 54-24.3-05, 54-24.3-06,
- 4 54-24.3-07, 54-24.3-08, 54-24.3-09, 54-24.3-10, 54-24.3-11, 54-24.3-12, 54-24.3-13,
- 5 54-24.3-14, 54-24.3-15, and 54-24.3-16 of the North Dakota Century Code, relating to the state
- 6 library and multitype library authorities; to repeal sections 54-24-07 and 54-24.3-02 of the North
- 7 Dakota Century Code, relating to state library printing costs and the statewide library planning
- 8 committee; and to provide appropriations.

## 9 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 54-24-02 of the North Dakota Century Code is
 amended and reenacted as follows:

12 **54-24-02.** Library offices. The state library must be furnished with adequate office

13 room, with such suitable quarters as may be necessary for the proper shelving of the

14 educational reference its library, the books of the traveling libraries, and the legislative

15 reference collection materials.

16 SECTION 2. AMENDMENT. Section 54-24-03 of the North Dakota Century Code is

17 amended and reenacted as follows:

- 18 **54-24-03.** Powers and duties of state librarian. The state librarian shall:
- 19 1. Make rules for the operation of the state library.
- 20 2. Provide and care for all books and library materials in all collections of the state
- 21 library, general, reference, and special, and make all rules regarding the loaning
- 22 and returning of library materials and work to focus the collections.
- 23 3. Employ qualified library personnel to care for all library procedures.

1 4. Make library materials available to libraries throughout the state, to individuals 2 connected with departments of state, and to citizens of North Dakota who do not 3 have adequate library facilities, under the rules of the state library. 4 5. Promote and assist by counsel and encouragement the formation of libraries and 5 the improvement of those already established, in keeping with state and national 6 standards, and be available to librarians and trustees of libraries in the state for 7 assistance in organization, maintenance, or administration of the libraries. Work to 8 improve library services to citizens by providing assistance to librarians and library 9 trustees and staff and by encouraging the extension of networking and regional 10 and statewide cooperation among libraries. 11 6. Coordinate the efforts of librarianship throughout the state, advising and assisting 12 the extension of qualified public libraries into centers of county or regional 13 (multicounty) multicounty libraries. 14 Compile statistics of the free public on all North Dakota libraries of North Dakota 7. 15 and their services and their larger counterparts of county and regional multicounty 16 libraries, regional library cooperatives including multitype library authorities, and of 17 the work done at the state library, and make a full biennial report to the 18 superintendent of public instruction and the governor. The state librarian may not 19 require a private sector library to submit information relating to the provisions of 20 this subsection. 21 8. Collect, maintain, and make available a reference and reading collection of books, 22 slides, films, and other graphic informational materials that supplement and 23 support the needs of all libraries in the state, either by direct loan or by 24 consultation, and that form a reference source for the officers of the state in 25 performing their duties. 26 9. Collect and maintain a collection of the publications of the departments and 27 agencies of state government, including the enacted laws of this state, current 28 session laws, and journals. Assist libraries in developing local standards and 29 guidelines defining the basic level of service that they will provide.

1 10. Conduct, or have conducted, research into the conditions of library service in the 2 state, and produce written plans for the development and betterment of that 3 service. 4 11. Compile, or have compiled, union lists of resources of libraries throughout the 5 state, and make those lists available for consultation. Promote and assist in the 6 development of regional library cooperatives, including multitype library authorities. 7 12. Establish levels of certification for librarians libraries of the state that meet the 8 standards recommended by the American library association and the North Dakota 9 library association. 10 13. Promote and assist libraries in this state in developing and maintaining a 11 computerized, comprehensive, bibliographic statewide data base for storing 12 bibliographic records of libraries which allows residents unmediated, seamless, 13 direct access to library catalogs with a common interface and a common set of 14 commands and the ability to search the library collections of the entire state at one 15 time or only the collections of the local library, regional libraries, or select group of 16 libraries. 17 14. Coordinate interlibrary loan activities throughout this state. 18 15. Arrange for continuing education and training programs for library personnel. 19 16. Provide technical assistance and counsel to library personnel. 20 17. Distribute grants to libraries within the limits of legislative appropriations for the 21 purpose of developing or improving library services or programs. 22 18. Provide staff services to the North Dakota library coordinating council. 23 **SECTION 3. AMENDMENT.** Section 54-24-09 of the 1995 Supplement to the North 24 Dakota Century Code is amended and reenacted as follows: 25 54-24-09. Distribution of certain state publications for certain libraries required. 26 The state purchasing and printing agent shall arrange to deposit with the state library eight 27 copies of all publications issued by all executive, legislative, and judicial agencies of state 28 government intended for general public distribution. These publications must be provided to 29 the state library without charge. Should If expense and limited supply of state publications, 30 particularly audiovisual items, make strict compliance with the depository requirement 31 impossible, the state library shall accept as many copies as an agency can afford to provide.

1 However, each agency shall provide no less than two copies must be provided to the state 2 library by each agency. State publications refer to any informational materials regardless of 3 format, method of reproduction, or source, originating in or produced with the imprint of, by the 4 authority of, or at the total or partial expense of, any state agency. The definition incorporates 5 those publications that may or may not be financed by state funds but are released by private 6 bodies such as research and consultant firms under contract with or supervision of any state 7 agency. In circumstances not directly involving the state purchasing and printing agent, a state 8 agency shall comply with the depository requirement by arranging with the necessary parties 9 for the printing and deposit of eight copies of any state publication issued. State publications 10 are specifically defined as public documents appearing as reports, directories, statistical 11 compendiums, bibliographies, laws or bills, rules, regulations, newsletters, bulletins, state 12 plans, brochures, periodicals, committee minutes, transcripts of public hearings, other printed 13 matter, audiotapes, videotapes, films, filmstrips, or slides, but not those administrative or 14 training materials used only within the issuing agency. As the document acquisition and 15 distribution agency, the state library shall retain for its own use document collection two copies 16 of every state document received and transmit the remaining copies to the depository libraries. 17 These are the libraries of the state historical board, the university of North Dakota, North 18 Dakota state university, library of Congress, and two others to be designated by the state 19 library. All nondepository North Dakota libraries shall have the opportunity to may receive state 20 documents under an optional selection program developed by the state library. The state 21 library shall catalog state publications and arrange for their conversion to microfilm or to optical 22 disk storage prescribed by the state records administrator and shall make available for 23 distribution the same to the designated depository libraries.

SECTION 4. AMENDMENT. Section 54-24.3-01 of the 1995 Supplement to the North
 Dakota Century Code is amended and reenacted as follows:

The interim planning committee must 13 consist of two lay representatives residing within the authority cooperative and five librarians. 14 The librarians must, as far as practical, must represent public libraries, academic libraries, 15 school library media centers, and special libraries. 16 SECTION 8. AMENDMENT. Section 54-24.3-06 of the 1995 Supplement to the North 17 Dakota Century Code is amended and reenacted as follows: 18 54-24.3-06. Multitype library authority Regional library cooperative interim 19 planning committee - Duties. In the administration of this chapter, the multitype library 20 authority regional library cooperative interim planning committee may: 21 1. Elect provisional officers: 22 Identify all librarians eligible to be members of the multitype library authority 2. 23 regional library cooperative; 24 3. Hold informational meetings: 25 4. Distribute and receive applications for memberships in the multitype library 26 authority regional library cooperative; 27 5. Draft interim bylaws for the multitype library authority regional library cooperative; 28 6. Prepare papers of incorporation; 29 7. Publicize activities;

- 8. Prepare a three-year plan for the development of services within the authority
   <u>cooperative</u> and present it to the statewide planning committee North Dakota
   library coordinating council for review and approval; and

9. Exercise any other duty that is necessary to carry out this chapter.

5 SECTION 9. AMENDMENT. Section 54-24.3-07 of the 1995 Supplement to the North
6 Dakota Century Code is amended and reenacted as follows:

7 54-24.3-07. Multitype library authority Regional library cooperative - Membership. 8 To join the regional multitype library authority library cooperative, a library shall must obtain 9 official approval from its board and submit an application to the interim planning committee. A 10 library that agrees to provide to any person residing within the authority cooperative access to 11 its collection on the premises, reciprocal borrowing privileges, and interlibrary loan service, may 12 apply for membership. To be eligible for membership, a library shall must have defined service 13 objectives, a fixed location, regular hours of service, an organized collection of information and 14 materials accessible for use by its designated clientele, and a qualified and responsible staff. 15 The library shall must have an identifiable organizational structure and a legal basis for 16 operation. The library shall must be willing and able to participate in appropriate services and 17 programs as set forth by the multitype library authority regional library cooperative. The 18 multitype library authority regional library cooperative interim planning committee shall review 19 all applications and approve applicants for membership.

SECTION 10. AMENDMENT. Section 54-24.3-08 of the 1995 Supplement to the North
 Dakota Century Code is amended and reenacted as follows:

22 54-24.3-08. Multitype library authority Regional library cooperative - Board. Each 23 participating library shall designate a representative to sit on the board of the multitype library 24 authority regional library cooperative. At its first meeting, the board shall elect a president, vice 25 president, treasurer, and any other officer it determines to be necessary. The director of the 26 designated library resource center shall serve as an ex officio nonvoting member of the board. 27 The board shall meet at least six times a year and has the power to contract, hire staff and set 28 compensation levels, and adopt bylaws for the conduct of its business. The term of office for all 29 officers of the board is one year, commencing on the January first after election. 30 SECTION 11. AMENDMENT. Section 54-24.3-09 of the 1995 Supplement to the North

Private and parochial school media centers located within each public school district are a single entity, and shall elect one voting representative from among themselves.

No member may withdraw unless it has been 25 a participant in the multitype library authority regional library cooperative for at least five two 26 years at the time of termination. The withdrawing member shall return all property of the 27 multitype library authority regional library cooperative.

3 SECTION 19. Chapter 54-24.4 of the North Dakota Century Code is created and
4 enacted as follows:

5 54-24.4-01. North Dakota library coordinating council - Members - Term. The 6 North Dakota library coordinating council consists of ten members. The president of the North 7 Dakota library association is an ex officio, voting member of the council. The state librarian is 8 an ex officio nonvoting member of the council. The governor shall appoint eight members to 9 the council, one of whom must represent special libraries, one of whom must represent public 10 higher education institution libraries, one of whom must represent private higher education 11 institution libraries, one of whom must represent school libraries, two of whom must represent 12 public libraries, one of whom must represent disabled, economically disadvantaged, and 13 minority populations, and one citizen at large. The governor shall take into account reasonable 14 geographic considerations when appointing members of the council. The term of each member 15 is three years. Of the initial council, three members must be appointed by the governor for a 16 three-year term, three members must be appointed by the governor for a two-year term, and 17 two members must be appointed by the governor for a one-year term. If at any time during a 18 member's term, the member ceases to possess the qualifications required by this section, the 19 member's office is deemed vacant and the governor shall appoint a qualified representative to 20 complete the term of office. No member may be appointed to serve more than two consecutive 21 three-year terms. 22 54-24.4-02. North Dakota library coordinating council - Compensation and 23 expense reimbursement. Each member of the North Dakota library coordinating council is 24 entitled to receive the same per day compensation as provided for members of the legislative

25 council under section 54-35-10, together with expenses as provided in sections 44-08-04 and

26 <u>54-06-09</u>, while attending meetings or performing duties directed by the council. No

27 compensation may be paid under this section to any council member who receives

28 <u>compensation as a regular state official or employee.</u>

much of the sum as may be necessary, to the state library for the purpose of connecting library
information systems currently operating in the state to allow residents access to library
collections included in these systems with one seamless unmediated search, for the biennium
beginning July 1, 1997, and ending June 30, 1999.

5 SECTION 22. APPROPRIATION. There is hereby appropriated out of any moneys in 6 the general fund in the state treasury, not otherwise appropriated, the sum of \$70,000, or so 7 much of the sum as may be necessary, to the state library for the purpose of providing grants to 8 libraries, schools, or regional library cooperatives to assist them in accessing the internet, for 9 the biennium beginning July 1, 1997, and ending June 30, 1999. The state library shall 10 distribute the grants to libraries, schools, or regional library cooperatives as directed by the 11 North Dakota library coordinating council. The North Dakota library coordinating council shall 12 award grants based on the following criteria:

13	1.	A library, school, or regional library cooperative receiving a grant must provide
14		matching funds.
15	2.	When possible, libraries, schools, and regional library cooperatives should
16		establish partnerships to create and maintain networks.
17	3.	Projects receiving grants must acknowledge and respond to the needs of the
18		public.
19	4.	Internet access for public users must be ensured and the network must be
20		accessible, easy to operate, attractive, and well-supported through training,
21		technical support, maintenance, and upgrading of the network and its associated
22		equipment.
23	5.	The network must be developed and operated with broad participation and input
24		from users.
25	6.	The network must meet appropriate state, national, and international standards
26		and specifications and have the capability to connect with existing
27		telecommunications systems.
