1 A BILL for an Act to create and enact a new section to chapter 20.1-03 of the North Dakota
2 Century Code, relating to hunting by nonresident and foreign exchange students; to amend and
3 reenact sections 20.1-03-07 and 20.1-03-07.1 of the North Dakota Century Code, relating to
4 hunting by nonresidents and nonresident waterfowl hunting licenses; and to provide an
5 expiration date.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. AMENDMENT.** Section 20.1-03-07 of the 1995 Supplement to the North
8 Dakota Century Code is amended and reenacted as follows:

9 **20.1-03-07. Licenses to hunt, trap, or fish required of nonresidents.** Nonresidents,
10 except as provided in sections 20.1-02-05 ~~and~~, 20.1-03-08, and section 3 of this Act, may not:

- 11 1. Hunt, catch, take, or kill any small game without a nonresident small game license.
- 12 2. Trap, catch, attempt to catch, take, or kill any protected fur-bearing animal except
13 that nonresidents holding a valid nonresident fur-bearer and nongame hunting
14 license may hunt only fox and coyote and residents of a state that allows North
15 Dakota residents to trap within that state may purchase a nonresident reciprocal
16 trapping license to trap in this state. However, a nonresident holding a valid
17 nonresident reciprocal trapping license may not trap, catch, attempt to catch, take,
18 or kill bobcats.
- 19 3. Catch, attempt to catch, take, or kill any fish without having a nonresident fishing
20 license.
- 21 4. Hunt, catch, take, or kill any unprotected bird or animal without having a
22 nonresident nongame hunting license or nonresident fur-bearer and nongame
23 hunting license.

1 5. Hunt, catch, take, or kill any big game animal without having the respective
2 nonresident big game license.

3 Each violation of this section is a distinct and separate offense.

4 **SECTION 2. AMENDMENT.** Section 20.1-03-07.1 of the 1995 Supplement to the
5 North Dakota Century Code is amended and reenacted as follows:

6 **20.1-03-07.1. Nonresident waterfowl hunting license required.** Except as provided
7 in section 20.1-03-07.2 and section 3 of this Act, a nonresident may not hunt waterfowl unless
8 that person first obtains a nonresident waterfowl hunting license, in addition to a nonresident
9 small game hunting license. The nonresident waterfowl hunting license entitles the nonresident
10 to hunt waterfowl for any period of fourteen consecutive days or any two periods of seven
11 consecutive days each and in specified waterfowl hunting zones. A license authorizing two
12 7-day hunting periods may allow hunting in a different zone during each period. The governor,
13 in the governor's proclamation, shall specify various waterfowl hunting zones for which
14 nonresident waterfowl hunting licenses will be available, and may specify the number of
15 licenses which may be issued in each zone and the manner in which they are to be issued. A
16 nonresident is entitled to purchase only one nonresident waterfowl hunting license per year.

17 **SECTION 3.** A new section to chapter 20.1-03 of the North Dakota Century Code is
18 created and enacted as follows:

19 **Hunting by nonresident and foreign exchange students.** A nonresident who is a
20 full-time student at an institution of higher education in this state and who resides in this state
21 during the school year or a nonresident who is a full-time foreign exchange student at a high
22 school in this state and who resides with a person in this state may obtain a resident fishing
23 license or resident small game hunting license by providing proof of student status and
24 residence as prescribed by the director.

25 **SECTION 4. EXPIRATION DATE.** This Act is effective through July 31, 1999, and
26 after that date is ineffective.
