| 2 | entitled to two staff assistants, but each majority or minority leader may hire fewer or more |
| 3 | assistants so long as the total daily compensation for the assistants hired does not exceed the |
| 4 | total daily amount authorized for those positions by this resolution; and |
| 5 | BE IT FURTHER RESOLVED, that the report of the Employment Committee of the |
| 6 | respective house identify the number of employees in each position by listing every employee |
| 7 | and the position for which employed; and |
| 8 | BE IT FURTHER RESOLVED, that with the approval of the Employment Committee of |
| 9 | the respective house, a position may be converted to a part-time position, with the daily |
| 10 | compensation converted to a per hour rate of pay; and |
| 11 | BE IT FURTHER RESOLVED, that if any employee resigns, is discharged, or for other |
| 12 | reasons terminates employment, the compensation provided by this resolution for that |

13 employee ceases effective the last day of employment.
