4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

| 5 | SECTION 1. APPROPRIATION. The funds provided in thi | s section, or so much of the |

to \$1,130,139 in funds generated by the state auditor from political subdivision audit service fees for the period beginning July 1, 1997, and ending June 30, 1999. Any amount in excess of \$1,130,139 must be deposited in the state auditor operating account and made available for appropriation after June 30, 1999.

SECTION 3. LINE ITEM TRANSFERS. Upon approval of the emergency commission, the state auditor may transfer between various line items in section 1 of this Act appropriation authority of up to ten percent of a given line item to adjust for changing circumstances in

- 3 **SECTION 4. AMENDMENT.** Section 54-10-10 of the 1995 Supplement to the North
- 4 Dakota Century Code is amended and reenacted as follows:
- 5 54-10-10. Salary of state auditor. The annual salary of the state auditor is fifty-two
- 6 <u>fifty-five</u> thousand seven four hundred eighty-seven sixty-four dollars through June 30, 1996
- 7 1998, and fifty-three fifty-seven thousand eight one hundred forty-three twenty dollars
- 8 thereafter.
