

**FIRST ENGROSSMENT  
with Senate Amendments**Fifty-fifth

of North Dakota**ENGROSSED HOUSE BILL NO. 1004**

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state auditor;  
2 and to amend and reenact section 54-10-10 of the North Dakota Century Code, relating to the  
3 salary of the state auditor.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the  
6 funds as may be necessary, are hereby appropriated out of any moneys in the general fund in  
7 the state treasury, not otherwise appropriated, and from special funds derived from federal  
8 funds and other income, to the state auditor for the purpose of defraying the expenses of the  
9 state auditor, for the biennium beginning July 1, 1997, and ending June 30, 1999, as follows:

17 **SECTION 2. APPROPRIATION.** Section 1 of this Act includes an appropriation of up  
18 to \$1,130,139 in funds generated by the state auditor from political subdivision audit service  
19 fees for the period beginning July 1, 1997, and ending June 30, 1999. Any amount in excess of  
20 \$1,130,139 must be deposited in the state auditor operating account and made available for  
21 appropriation after June 30, 1999.

22 **SECTION 3. LINE ITEM TRANSFERS.** Upon approval of the emergency commission,  
23 the state auditor may transfer between various line items in section 1 of this Act appropriation  
24 authority of up to ten percent of a given line item to adjust for changing circumstances in

1 meeting established performance measures. Any further transfers must be approved by the  
2 budget section.

3 **SECTION 4. AMENDMENT.** Section 54-10-10 of the 1995 Supplement to the North  
4 Dakota Century Code is amended and reenacted as follows:

5 **54-10-10. Salary of state auditor.** The annual salary of the state auditor is ~~forty-two~~  
6 ~~fifty-five~~ thousand ~~seven~~ four hundred ~~eighty-seven~~ sixty-four dollars through June 30, ~~1996~~  
7 ~~1998~~, and ~~fifty-three~~ fifty-seven thousand ~~eight~~ one hundred ~~forty-three~~ twenty dollars  
8 thereafter.
