FIRST ENGROSSMENT with Senate Amendments

ENGROSSED HOUSE BILL NO. 1028

- 1 A BILL for an Act to provide an appropriation for defraying the expenses of various state
- 2 departments and institutions; to provide for a transfer from the accumulated and undivided
- 3 profits of the Bank of North Dakota to the general fund; to create and enact a new section to
- 4 chapter 5 of the 1995 Session Laws, relating to capital improvements at the north central
- 5 research center; to amend and reenact section 4 of chapter 25 of the 1995 Session Laws,
- 6 relating to state employee defense costs; and to declare an emergency.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

8 **SECTION 1. APPROPRIATION.** There is hereby appropriated out of any moneys in 9 the general fund in the state treasury, not otherwise appropriated, and from special funds 10 derived from federal funds and other income, the sums as hereinafter provided or so much of 11 the sums as may be necessary. These sums increase the general fund and special funds 12 appropriation authority enacted by the fifty-fourth legislative assembly to the stated 13 departments and institutions of the state of North Dakota for the purpose of defraying their 14 expenses, for the period beginning January 1, 1997, and ending June 30, 1997, as follows: 15 Subdivision 1. 16 OFFICE OF MANAGEMENT AND BUDGET 17 Administration \$ 863,481 25,000 18 Facility management Total general fund appropriation \$ 888,481 19 20 Subdivision 2. 21 OFFICE OF THE ATTORNEY GENERAL 22 Grants \$ 153,000 23 Total general fund appropriation \$ 153,000 24 Subdivision 3.

17	SECTION 2. TRANSFER. If a settlement is reached with the United States department	
18	of health and human services, there is hereby transferred from the accumulated and undivided	
19	profits of the Bank of North Dakota to the general fund, an amount equal to the amount set forth	
20	in the settlement agreement for settlement of a claim made against the state for imputed	
21	interest on health professions student loan and nursing student loan program funds held by	
22	various North Dakota institutions of higher learning. The amount of the transfer provided for in	
23	this Act may not exceed \$214,540. The industrial commission shall transfer the amount	
24	necessary for payment of the settlement agreed to into the general fund within ten days of	
25	execution of an agreement between the state and the United States department of health and	
26	human services or the effective date of this Act, whichever is later. In the event section 5 of	
27	this Act does not become effective, the industrial commission shall transfer to the general fund	
28	the amount necessary to pay the settlement on July 1, 1997.	
29	SECTION 3. APPROPRIATION. There is hereby appropriated to the North Dakota	
30	university system out of any moneys in the general fund in the state treasury, not otherwise	
31	appropriated, the sum of \$214,540, or so much of that amount as may be necessary, to comply

1 with the terms of a settlement agreement of claims made against the state by the United States 2 department of health and human services for imputed interest on health professions student 3 loan and nursing student loan program funds held by various institutions of higher learning. 4 The North Dakota university system shall disburse the funds appropriated by this section in 5 amounts not to exceed the amounts set forth below to the: 6 Nursing student loan program at North Dakota state university \$ 25,888 7 Nursing student loan program at Minot state university 42.887 8 Health professions student loan program at the university 2.852 9 of North Dakota 10 Nursing student loan program at the university of North Dakota 32,973 11 United States department of health and human services 109,940 12 The state board of higher education shall disburse the amounts set forth above, or a lesser 13 amount as required by the settlement agreement reached with the United States department of 14 health and human services, within ten days of the date the industrial commission makes the 15 transfer provided for in section 3 of this Act, but in any event the board shall pay the settlement 16 on or before July 11, 1997. 17 SECTION 4. A new section to chapter 5 of the 1995 Session Laws is created and 18 enacted as follows: 19 NORTH CENTRAL RESEARCH CENTER CAPITAL IMPROVEMENTS. The capital 20 improvements line item in subdivision 8 of section 1 of this Act may be used to construct a new 21 headquarters building at the north central research center. 22 SECTION 5. AMENDMENT. Section 4 of chapter 25 of the 1995 Session Laws is 23 amended and reenacted as follows: 24 **SECTION 4. BONDING FUND.** The appropriation in section 1 of this Act includes up 25 to \$250,000, or so much of the sum as may be necessary, from the state bonding fund to the 26 attorney general for the purpose of providing state employee defense services pursuant to 27 section 26.1-21-10.2. The emergency commission, notwithstanding section 54-16-04, is 28 authorized during the biennium beginning July 1, 1995, and ending June 30, 1997, to approve 29 the expenditure of the funds from the state bonding fund appropriated in section 1 of this Act to 30 the extent necessary and based upon applications by the attorney general. Funds expended

by the attorney general for state employee defense must be reimbursed to the state bonding

- 1 fund through deficiency appropriation and the attorney general shall report to the budget
- 2 section of the legislative council the amount of any deficiency appropriation that may be
- 3 introduced to the fifty-fifth legislative assembly.
- 4 **SECTION 6. LEGISLATIVE INTENT.** It is the intent of the fifty-fifth legislative
- 5 assembly that the general fund appropriation of \$863,481 included in subdivision 1 of section 1
- 6 of this Act is to be used by the administration division of the office of management and budget
- 7 to pay the United States department of health and human services for its share of fire and
- 8 tornado fund money previously transferred to the general fund of the state treasury. If this
- 9 appropriation is not sufficient to pay the amount due, including interest, the director of the office
- 10 of management and budget may request state contingencies funding from the emergency
- 11 commission, use available general fund moneys appropriated to the fiscal management division
- 12 of the office of management and budget, or request a deficiency appropriation from the
- 13 fifty-sixth legislative assembly to obtain funds to pay the remaining amount due.
- **SECTION 7. EMERGENCY.** This Act is declared to be an emergency measure.
