## ENGROSSED HOUSE BILL NO. 1029

Introduced by

**Appropriations Committee** 

(At the request of the Governor)

- 1 A BILL for an Act to provide an appropriation for capital projects of various state departments
- 2 and institutions; to authorize the state board of higher education to issue and sell
- 3 self-liquidating, tax-exempt bonds for the construction of a revenue-producing parking lot and
- 4 related facilities at the university of North Dakota; to authorize the industrial commission to
- 5 issue and sell bonds for capital projects; to provide an appropriation; to amend and reenact
- 6 section 54-17.2-23 of the North Dakota Century Code, relating to the limitation on state building
- 7 authority lease payments; and to declare an emergency.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

## 9 SECTION 1. BOARD OF HIGHER EDUCATION - BOND ISSUANCE - PURPOSES.

- 10 The state board of higher education, in accordance with chapter 15-55, may issue and sell
- 11 self-liquidating, tax-exempt bonds in any amount up to, but not exceeding \$450,000 for the
- 12 purpose of financing a revenue-producing parking lot, curb, gutter, sidewalks, and ring road in
- 13 connection with the rural technology center at the university of North Dakota. Bonds issued
- 14 under the provisions of this Act may not become a general obligation of the state of North
- 15 Dakota.

- 16 SECTION 2. USE OF PROCEEDS APPROPRIATION. The proceeds resulting from
- 17 the sale of bonds authorized under section 1, or so much thereof as may be necessary, plus
- 18 any available funds received from federal or private sources, are hereby appropriated to
- 19 reimburse the state board of higher education for the construction costs of the facility
- 20 authorized in section 1.
- 21 **SECTION 3. PROJECT AUTHORIZATIONS.** The industrial commission, acting as the
- 22 North Dakota building authority, shall arrange for the funding of the projects authorized in this
- 23 section, hereby declared to be in the public interest, through the issuance of evidences of
- 24 indebtedness under chapter 54-17.2, during the biennium beginning July 1, 1997, and ending

18	The industrial commission shall issue evidences of indebtedness under this section with		
19	the condition that lease rental payments need not begin until July 1, 1999. This authority of the		
20	industrial commission to issue evidences of indebtedness ends June 30, 1999, but the		
21	industrial commission may continue to exercise all other powers granted to it under chapter		
22	54-17.2 and this Act and to comply with any covenants entered into before that date.		
23	The university of North Dakota may obtain and utilize federal funds to assist in the		
24	construction of animal quarters at the university of North Dakota. There is hereby appropriated		
25	to the university of North Dakota the sum of \$1,500,000, or so much of the sum as may be		
26	necessary, from any federal or other funds that may become available for this project for the		
27	biennium beginning July 1, 1997, and ending June 30, 1999.		

North Dakota state university may obtain and utilize federal funds to assist in the construction of an animal research facility at North Dakota state university. There is hereby appropriated to North Dakota state university the sum of \$5,000,000, or so much of the sum as

1 may be necessary, from any federal or other funds that may become available for this project 2 for the biennium beginning July 1, 1997, and ending June 30, 1999. 3 The general funds and special funds contained in section 3 of chapter 3 of the 1995 4 Session Laws for Bute gymnasium at the North Dakota state college of science are not subject 5 to the provisions of section 54-44.1-11 and any unexpended funds from these appropriations 6 are available during the biennium beginning July 1, 1997, and ending June 30, 1999. 7 Grand total special funds appropriation \$27,515,000 8 SECTION 4. BOND ISSUANCE REPAYMENT RESPONSIBILITY. Of the total 9 amount of evidences of indebtedness issued under the provisions of section 3 of this Act, a 10 total of \$2,800,000 must be available from nongeneral fund sources to assist in the retirement 11 of the evidences of indebtedness, issued for the project costs associated with construction of 12 the projects authorized by this Act: 13 University of North Dakota project \$1,500,000 14 1,000,000 North Dakota state university project 15 North Dakota state college of science project 300.000 16 Payments must be made in six equal annual installments beginning after fiscal year 1999. 17 Prepayment may be made on any or all of these amounts. Such payments of local matching 18 amounts must be deposited in a special industrial commission account from which the industrial 19 commission, acting as the North Dakota building authority, shall use the funds in making 20 principal and interest payments. **SECTION 5. AMENDMENT.** Section 54-17.2-23 of the 1995 Supplement to the North 21 22 Dakota Century Code is amended and reenacted as follows: 23 **54-17.2-23.** State building authority lease payments - Limitation. The general fund 24 amount of lease payments for a biennium associated with capital construction projects financed 25 by the industrial commission acting as the state building authority may not exceed the amount 26 equal to a portion of sales, use, and motor vehicle excise tax collections equal to eleven ten
