# ENGROSSED SENATE BILL NO. 2113

(At the request of the Board of Psychologist Examiners)

#### 1 A BILL for an Act to create and enact five new sections to chapter 43-32 of the North Dakota

- 2 Century Code, relating to powers of the board of psychologist examiners, investigations,
- 3 licensure renewal, and disciplinary hearings; to amend and reenact sections 43-32-01,

4 43-32-02, 43-32-03, 43-32-05, 43-32-08.1, 43-32-13, 43-32-14, 43-32-16, 43-32-19, 43-32-20,

5 43-32-21, 43-32-27, 43-32-29, and 43-32-30 of the North Dakota Century Code, relating to the

6 board of psychologist examiners, licensure and regulation of psychologists, continuing

7 education, and client records; and to repeal sections 43-32-18 and 43-32-28 of the North

8 Dakota Century Code, relating to licensing of psychologists without examination and

9 disciplinary hearings.

### 10 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

2		psychological aspects of physical illness, accident, injury, or disability; and
3		psychoeducational evaluation, therapy, remediation, and consultation. The term
4		includes the rendering of providing psychological services to individuals, families,
5		groups, and the public and is without regard to regardless of whether payment is
6		received for services rendered.
7	3.	"Psychologist" means an individual who is licensed under this chapter in the
8		practice of psychology.
9	4.	"Psychology resident" means an individual who has received from an accredited
10		school or college a doctorate degree in a program of study substantially
11		psychological in nature, and who is involved in supervised psychological
12		employment.
13	<u>5.</u>	"School or college" means any university or other institution of higher learning that
14		is accredited by a regional accrediting association, offering a full-time graduate
15		course of study in psychology.

Cooperation includes responding fully and promptly to 16 any reasonable question raised by or on behalf of the board relating to the subject 17 of the investigation, and providing copies of patient records when reasonably 18 requested by the board and accompanied by the appropriate release.
- 19 In order to pursue an investigation, the board may subpoena and examine 4. 20 witnesses and records, including patient records, and copy, photograph, or take 21 samples. The board may require the licensed psychologist to give statements 22 under oath, to submit to a physical or psychological examination, or both, by a 23 physician or other qualified evaluation professional selected by the board, if 24 requiring an examination is in the best interest of the public. The patient records 25

released to the board are not public records.

26 Unless a patient release is on file allowing the release of information at the public 5. 27 hearing, patient records acquired by the board in its investigation are confidential 28 and closed to the public. All board meetings at which patient testimony or records 29 are taken or reviewed are confidential and closed to the public. If no patient 30 testimony or records are taken or reviewed, the remainder of the meeting is an 31 open meeting unless a specific exemption is otherwise applicable.

8	<u>8.</u>	A person employed by an agency, nonprofit corporation, or institution who is
9		currently exempt from licensure continues to be exempt if the person continues
10		employment in the same position with the agency, nonprofit corporation, or
11		institution that applied for and received the exemption.
