- 1 A BILL for an Act to create and enact three new sections to chapter 43-47 of the North Dakota
- 2 Century Code, relating to the authority of the board of counselor examiners to appoint or
- 3 employ persons, payment of delinquent license fees, and unauthorized practice of counseling;
- 4 to amend and reenact section 43-47-01, subsection 3 of section 43-47-02, sections 43-47-03,
- 5 43-47-06, and 43-47-08 of the North Dakota Century Code, relating to definitions, duties,
- 6 responsibilities, license qualifications, and complaints and investigations applicable to the board
- 7 of counselor examiners; and to provide a penalty.

8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 9 **SECTION 1. AMENDMENT.** Section 43-47-01 of the 1995 Supplement to the North 10 Dakota Century Code is amended and reenacted as follows:
- 11 **43-47-01. Definitions.** As used in this chapter, unless the context otherwise requires:
- 12 1. "Board" means the board of counselor examiners.
- 13 2. "Counseling" means assisting an individual, group, or family to develop 14 understanding of intrapersonal and interpersonal problems; to define and set goals, 15 make decisions, and plan a course of action reflecting the needs, interests, and 16 abilities of the person or persons; and to use informational and community 17 resources as needed for personal, social, educational, and vocational development 18 and adjustment the application of human development and mental health principles 19 in a therapeutic process and professional relationship to assist individuals, couples, 20 families, and groups in achieving more effective emotional, mental, marital, family, 21 and social or educational development and adjustment. The goals of professional 22 counseling are to:
 - a. Facilitate human development and adjustment throughout the life span;

Has provided a statement of professional intent to practice in this state 2 describing the applicant's proposed use of the license, the intended client 3 population, and the counseling procedures, as defined by the board, the 4 applicant intends to use in serving the client population; and 5 Has demonstrated knowledge in the field of counseling by successful e. 6 completion of an examination prescribed by the board. 7 3. The board shall issue a license as a licensed associate professional counselor to 8 each applicant who files an application upon a form and in a manner the board 9 prescribes, accompanied by the required fee, and who furnishes sufficient 10 evidence to the board that the applicant: 11 Has received a master's degree from an accredited school or college in 12 counseling or other program that meets the academic and training standards 13 adopted by the board: 14 b. Has provided personal and professional recommendations that meet the 15 requirements adopted by the board and has satisfied the board that the 16 applicant will adhere to the standards of the profession of counseling; and 17 Has provided a written plan for supervised experience which meets the C. 18 requirements adopted by the board. 19 4. The board may waive the formal examination requirements for a professional 20 counselor license when the applicant has been licensed or certified to practice 21 counseling in another state under standards and qualifications similar or greater to 22 those set by the board. 23 5. A professional counselor shall renew the license every two years. The board shall 24 renew a license upon payment of a fee set by the board and upon demonstration 25 by the licenseholder of completion of continuing education requirements set by the 26 board. 27 An associate professional counselor initially licensed under this chapter may be 6.

licensed for no more than two years. The associate professional counselor's

license may be extended beyond two years only upon recommendation of the

associate professional counselor's supervisor and three other counselors, at least

1 one of whom must be a professor from the associate professional counselor's 2 training program. 3 7. For a period of two years beginning on July 6, 1989, the board shall issue upon the 4 application of any person a license as a licensed professional counselor if the 5 applicant: 6 Has received a master's degree that is primarily counseling in content from a a. 7 regionally accredited institution of higher education; 8 Has worked for pay in the counseling field, including counselor education b. 9 during two of the previous five years; 10 Shows evidence of supervision or continued professional growth; and С. 11 Successfully completes an examination approved by the board. d. 12 **SECTION 6.** A new section to chapter 43-47 of the North Dakota Century Code is 13 created and enacted as follows: 14 Payment of delinquent license fees - Reinstatement. A person who has been licensed under this chapter, and whose license has not been renewed because of the failure to 15 16 pay the annual license fee, must be reinstated and the license renewed if within one year from 17 the date of nonrenewal the person pays to the secretary of the board the amount of the annual 18 license fee in default and a late fee to be determined by rule of the board. 19 SECTION 7. AMENDMENT. Section 43-47-08 of the North Dakota Century Code is 20 amended and reenacted as follows: 21 43-47-08. Complaints - Investigations. 22 A person aggrieved by the actions of a counselor licensed under this chapter may 23 file a written complaint with the board citing the specific allegations of misconduct 24 by the counselor. The board shall notify the counselor of the complaint and require 25 a written response from the counselor. Neither the initial complaint nor the 26 counselor's response is public record. The counselor's response must be made 27 available to the complainant. 28 A counselor who is the subject of an investigation by the board shall cooperate fully 29 with the investigation. Cooperation includes responding fully and promptly to any 30 reasonable question raised by or on behalf of the board relating to the subject of

- the investigation, and providing copies of patient records when reasonably requested by the board and accompanied by the appropriate release.
 - 3. In order to pursue the investigation, the board may subpoena and examine witnesses and records, including patient records, and copy, photograph, or take samples. It may require the counselor to give statements under oath, submit to a physical or psychological examination, or both, by a physician or physicians or other qualified evaluation professionals selected by the board if it appears to be in the best interest of the public that this evaluation be secured. A written request from the board constitutes authorization to release information. Patient records that are released to the board are not public records.
 - 4. After review of the complaint and, the counselor's response, and information obtained in the investigation, the board shall determine if there is a reasonable basis to believe that the allegations are true and that the allegations constitute a violation of this chapter or the rules of the board. If the board determines that there is a reasonable basis to believe that the allegations are true and that the allegations constitute a violation of this chapter or the rules of the board, the board shall take appropriate action. If a reasonable basis is not found by the board, the board shall so notify the complaining party and the counselor in writing.
 - 5. Unless there is a patient release on file allowing the release of information at the public hearing, patient records acquired by the board in its investigation are confidential and closed to the public. All board meetings wherein patient testimony or records are taken or reviewed are confidential and closed to the public. If no patient testimony or records are taken or reviewed, the remainder of the meeting is an open meeting unless a specific exemption is otherwise applicable.

SECTION 8. A new section to chapter 43-47 of the North Dakota Century Code is created and enacted as follows:

Unauthorized practice - Civil penalty. In addition to any other penalty, the board may levy a civil penalty of not more than one thousand dollars per offense upon any unlicensed person who, after a hearing or informal resolution in accordance with chapter 28-32, is found to have practiced counseling without a license issued by the board. In addition, the board may assess costs and attorneys' fees of the investigation and administrative proceeding against the

- 1 <u>unlicensed person found to have been practicing counseling without a currently valid license.</u>
- 2 An appeal from any fine imposed pursuant to this section may be made pursuant to the
- 3 provisions of chapter 28-32.
